WHEREAS, a public hearing was duly called for, and held on September 11, 2024, relative to a proposed local law to "Amend the Henrietta Town Code Relating to the Alternative Veterans Exemption to Increase the Benefit," and all interested parties were permitted an opportunity to speak thereon; and

WHEREAS, the Town Board of the Town of Henrietta, after due deliberation, finds it in the best interest of the Town to adopt said local law for the reasons set forth therein, and finds that the Henrietta Town Code should thus be amended as set forth herein.

THEREFORE, BE IT RESOLVED, that the Town Board hereby adopts said Local Law No. 7 of 2024, to amend the Henrietta Town Code relating to the Alternative Veterans exemption to increase the benefit, all as set forth in the attached Local Law, which is incorporated herein and made a part hereof.

BE IT FURTHER RESOLVED, that the Town Clerk of the Town of Henrietta be and hereby is directed to enter said Local Law into the minutes of this meeting and to give due notice of the adoption of said Local Law to the Secretary of State of the State of New York.

RESOLUTION ADOPTED

LOCAL LAW NO. 7 of 2024

A Local Law to Amend the Henrietta Town Code Relating to the Alternative Veterans Exemption to Increase the Benefit.

BE IT ENACTED, by the Town Board of the Town of Henrietta, Monroe County, State of New York, as follows:

Section I. Authorization

The adoption of this Local Law is in accordance with Section 458-A of the New York Real Property Tax Law.

Section II. Title and Purpose

This law shall be known as and may be cited as Local Law No.7 of 2024, to amend the Henrietta Town Code relating to the Alternative Veterans Exemption to increase the benefit beyond the minimum.

Section III. Legislative Finding

The Town Board of the Town of Henrietta finds and hereby determines that the Town values its veterans and thus wishes to increase their benefits to reflect increasing property values.

Section IV. Amendment

Chapter 250 entitled "Taxation," Article IV, Alternative Veterans Exemption," Subsection 250-16(A) (1-3), as last amended by Local Law No. 4 of 2006, shall be amended to read as follows:

- A. Pursuant to the authority granted by § 458-A of the Real Property Tax Law, real property in the Town of Henrietta owned by one or more persons who qualify as "veteran(s)" as defined in said section, shall be exempt from taxation by the Town of Henrietta to the extent authorized therein, subject to the following maximum exemptions, which are cumulative when applicable:

(1) Wartime Service	\$ 45,000
(2) Combat Service	\$ 30,000
(3) Service-Connected Disability	\$150,000

Section V. Validity and Severability

Should any word, section, clause, paragraph, sentence, part or provision of this local law be declared invalid by a court of competent jurisdiction, such determination shall not affect the validity of any other part hereof.

Section VI. Repeal, Amendment and Supersession of Other Laws

All other ordinances or local laws of the Town of Henrietta which are in conflict with the provisions of this local law are hereby superseded or repealed to the extent necessary to give this local law force and effect during its effective period.

Section VII. Effective Date

This Local Law will take effect upon filing in the office of the New York State Secretary of State.
