Councilmember Muscarella moved the following resolution's adoption:

RESOLUTION ADOPTING A LOCAL LAW TO ENACT SUB-PARAGRAPH (2) OF PARAGRAPH H. OF SECTION 202-58 OF CHAPTER 202, ENTITLED "PARKING," OF THE CODE OF THE TOWN OF HEMPSTEAD, IN RELATION TO TOW AWAY ZONES IN RESIDENTIAL AREAS IMMEDIATELY ADJACENT TO BELMONT PARK RACETRACK IN ELMONT AND BELLEROSE TERRACE, NEW YORK.

WHEREAS, the Town Board of the Town of Hempstead is empowered to enact and amend local laws pursuant to Article 9 of the New York State Constitution, the provisions of the Town Law and the Municipal Home Rule Law, as amended; and

WHEREAS, on the 21<sup>st</sup> day of May 2024, Councilmember Goosby introduced the proposed local law known as Intro. No. 41-2024, Print No. 1, to consider enacting Subparagraph (2) of Paragraph H. of Section 202-58 of Chapter 202 of the Code of the Town of Hempstead, in relation to tow away zones in residential areas immediately adjacent to Belmont Park Racetrack in Elmont and Bellerose Terrace, New York; and

WHEREAS, this Town Board on May 21<sup>st</sup>, 2024 duly adopted Resolution No. 613-2024, calling a public hearing on the adoption of said local law and said hearing was held on the 4<sup>th</sup> day of June, 2024, at which time all persons desiring to be heard thereon were heard; and

WHEREAS, the proposed local law has been on the desks of the members of the Town Board for seven calendar days, exclusive of Sunday; and

WHEREAS, it is in the public interest to enact Subparagraph (2) of Paragraph H. of Section 202-58 of Chapter 202 of the Code of the Town of Hempstead, in relation to tow away zones in residential areas immediately adjacent to Belmont Park Racetrack in Elmont and Bellerose Terrace, New York;

Now, therefore be it,

RESOLVED, the said local law to enact Subparagraph (2) of Paragraph H. of Section 202-58 of Chapter 202 of the Code of the Town of Hempstead, in relation to tow away zones in residential

areas immediately adjacent to Belmont Park Racetrack in Elmont and Bellerose Terrace, New York is adopted; and be it further,
