Legistlative Intent: The Village has been, and will continue to be, a village consisting of single family, non-manufactured homes. In order to keep the Village in its same or similar appearance as currently exists, only homes that comply with the Village Code coupled with Federal and State Codes and Statutes will be permitted. The storage of containers, manufactured homes, recreational vehicles, dumpsters and trailers on residential property detracts from the look and appearance of the Village. A.Manufactured Homes Defined (1) Any home that is pre-constructed in whole or in parts. Manufactured housing refers to factory-built homes that can be placed on a piece of land. Styles vary from modest trailers to dwellings that look like houses built permanently on a site. B. Mobile Homes Defined (1) A dwelling structure built on a steel chasis and fitted with wheels that is intended to be hauled to a usually permanent site. C.Recreational Vehicles Defined (1) A temporary dwelling for travel and recreation purposes and licensed as a motor home, camper or travel trailer. D.Trailers Defined (1) Trailers mean every vehicle with or without motive power designed for carrying property and for being drawn by a motor vehicle and constructed so that no part of its weight rests upon the towing vehicle such as a boat trailer or a jetski trailer, E. Shipping Containers Defined (1) A shipping container is manufactured with strength suitable to withstand shipment, storage and handling. Shipping containers are normally large reusable steel boxes used for intermodal shipments or storage. F.Dumpsters Defined (1) A container for receiving, transporting, and dumping waste materials. Permits are required. G.Manufactured homes, Mobile Homes, Recreational Vehicles, Trailers, and Shipping Containers Prohibited (1) No manufactured home, mobile home recreational vehicles or trailer is permitted on any property within the Village of Hewlett Harbor (2) No recreational vehicles, mobile homes, campers, trailers, shipping containers, buses,

travel trailers, boat trailers, jet ski trailers or any type of vehicle or structure used for the purpose of transportation, public or private business, or habitation, may remain on any street or property overnight within the Village. H. Exceptions (1) The Seawane Club may store shipping containers on its property with the proper permits as defined within the Village Code. (2) During construction, a dumpster, pod (an acronym and common name for portable on-demand storage units), or other container may be stored on residential or Seawane Golf Club property for a limited period of time with the proper permit as defined within the Village Code (3) a maximum 30-yard covered dumpster may be used by residents during construction, renovation, or clean-outs for a limited period of time with the proper permit as defined within the Village Code. L. Penalties for Offenses: Unless otherwise provided, any person, business, trust, or corporation violating any provision of this section as now enacted or hereafter amended, shall be liable for and shall pay a penalty not exceeding seven hundred and fifty dollars (\$750.00) for each violation. Each day that a violation occurs and every three (3) days that a violation continues shall constitute a separate and distinct violation for which said penalty not exceeding seven hundred and fifty dollars (\$750.00) shall be imposed. FIRST: Separability: If any section, sub-section, sentence, clause or phrase of this local law is for any reason held invalid or unconstitutional by decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portion of this local law. SECOND: Effective Date: This act shall take effect immediately and retroactively upon filing with the Secretary of State as provided by law.
