

**BOROUGH OF HELLERTOWN  
ORDINANCE NO.: 848**

**AN ORDINANCE OF THE BOROUGH OF HELLERTOWN, NORTHAMPTON COUNTY,  
PENNSYLVANIA AMENDING CHAPTER 425 ARTICLE III ENTITLED  
GENERAL PARKING REGULATIONS AND ESTABLISHING PARKING  
PROHIBITIONS IN SPECIFIED PLACES.**

WHEREAS, the Borough of Hellertown is empowered to establish and regulate the flow of traffic on municipal roadways and establish no parking on public streets pursuant to the Borough Code.

WHEREAS, pursuant to 75 Pa.C.S.A. Section 3351 et al, the Borough has the authority to regulate public street parking within the Borough of Hellertown.

WHEREAS, the Borough of Hellertown believes it is in the Public's health, safety and welfare to establish no parking zones in specified places located within the Borough.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE BOROUGH OF HELLERTOWN AND IT IS ENACTED AND ORDAINED AS FOLLOWS:

1.     **SECTION 1:** The Code of the Borough of Hellertown Chapter 425 Subsection 28, entitled "Parking prohibited at all times in certain locations" shall be amended by adding the below underscored language and by deleting the crossed-out language as follows:

§425-28: Manner of adopting permanent traffic and parking regulations.

All traffic and parking regulations of a permanent nature shall be enacted ~~as ordinances, as parts of ordinances~~ by Resolution of Borough Council.

2.     **SECTION 2:** The Code of the Borough of Hellertown Chapter 425 subsection 29 entitled, "Parking prohibited in certain locations, certain days and hours" Subsection B shall be amended by adding the below underlined language and deleting the below crossed out language as follows:

B. There shall be no ten, fifteen or thirty-minute parking time limit on Main Street in the Borough of Hellertown. All parking spaces on Main Street shall be limited to two-hour parking between the hours of ~~9:00 AM~~ 8:00 AM and 6:00 PM.

3. **SECTION 3:** The Code of the Borough of Hellertown Chapter 425 subsection 30 entitled, "Parking time limited in certain locations, certain days and hours" shall be ~~repealed in its entirety and replaced with the below language:~~ amended by adding the below:

§425-30 Parking time limited in certain locations, certain days and hours.

The above shall be added to Section §425-30 of the Borough Code of Ordinances and any inconsistencies currently set forth in Section §425-30 shall be modified according to conform to this ordinance.

4. **SECTION 4:** The Code of the Borough of Hellertown Chapter 425 subsection 31 entitled, “Handicapped Parking Zones established; parking otherwise prohibited” shall be modified by adding the below underlined language and deleting the below crossed out language as follows:

425-31. Handicapped parking zones established; parking otherwise prohibited.

(2) The following areas upon the streets in the Borough of Hellertown shall remain as “parking for handicapped” and subject to annual renewal in accordance with the terms of subsection B through F of this section and annual revision by formal Councilmanic action by Resolution as follows:

5. **SECTION 5:** The Code of the Borough of Hellertown Chapter 425 Section 38 entitled, "Bus Stops established" shall be modified as follows by adding the below to Section 425-38 as follows:

A. The following areas upon the highways in the Borough are hereby established as "bus stops" and no vehicle other than a bus engaged in loading and unloading or awaiting passengers, shall be parked in any such area at anytime.

6. **SECTION 6:** The Code of the Borough of Hellertown Chapter 425 Section 60 entitled, "Pedestrian – Control signal locations established" shall be modified as follows by adding the below to Section 425-60 as follows:

A. At the following locations official pedestrian-control signals shall be erected (or are ratified if previously erected):

Location

- Main Street and Walnut Street
- Main Street and Water Street
- Main Street and Saucon Street

Main Street and High Street  
Main Street and Thomas Street  
Main Street and Hampton  
Main Street and Wagner Street  
Main Street and Clarke Street


7. **SECTION 7: SEVERABILITY.** The provisions of this Ordinance shall be severable, and if any provision hereof shall be declared unconstitutional, illegal or invalid, such decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is hereby declared as a legislative intent of the Borough that this Ordinance would have been amended as if such unconstitutional, illegal or invalid provision or provisions had not been included herein.


8. **SECTION 8:** Any and all ordinances and/or parts hereon which are inconsistent herewith are hereby and the same repealed.
