

INTRODUCED BY Alderman Ash Geers

**AN ORDINANCE TO AMEND SECTIONS 220.190, 220.200, 220.210, 220.220, AND 220.205 OF THE MUNICIPAL CODE AND PRESCRIBING A SCHEDULE OF RATES FOR REFUSE CONTAINER LEASES FOR GARBAGE AND REFUSE COLLECTION AND FOR LIMITED SERVICE PICKUP.**

WHEREAS, the Board of Aldermen has authorized the execution of a Contract Renewal Agreement for Solid Waste Collection and Disposal between the City of Hermann, Missouri (“City”) and Tri-County Trucking and Excavating, Inc. (“Tri-County”); and

WHEREAS, said contract provides that the fees and charges cited therein would increase by 3.5% commencing July 10, 2024; and

WHEREAS, the City has determined that a 3.5% increase in refuse container rental and collection and disposal fees per said contract serves a legitimate public purpose and is in the best interests of the citizens of the City of Hermann, Missouri.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HERMANN, MISSOURI, AS FOLLOWS:

**SECTION ONE:** Sections 220.190, 220.200, 220.210, 220.220 and 220.205 of the Municipal Code are hereby amended to read as follows:

**SECTION 220.190: RENTAL OF GARBAGE AND REFUSE CONTAINERS**

The monthly rates to be charged by the City of Hermann for rental of garbage and refuse containers having a capacity of two (2) cubic yards and greater and for the collection and disposal of the contents thereof shall be as follows:

The monthly rates to be charged by the City of Hermann for garbage and refuse collection and disposal for residential and business customers of the City of Hermann shall be as follows:

**SECTION 220.205: LIMITED SERVICE PICKUP**

The fee for limited service pickup for garbage and rubbish disposal shall be seven dollars and twenty-two cents (\$7.22) per bag, which includes the cost of the bag and disposal. The subscriber to the service shall only use the bags purchased for service.

**SECTION 220.210: PUBLICATION OF RATES**

The City Clerk shall be and hereby is directed to cause notice of the above rates to be published in the next available edition of the Advertiser-Courier, as required by Section 220.150.

**SECTION 220.220: EFFECTIVE DATE OF RATES**

The rates provided above shall be effective for all rentals of such containers and collection and disposal of garbage and refuse on and after July 10, 2024.

**SECTION TWO:** All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

**SECTION THREE:** This Ordinance shall be in full force and effect from and after its final passage and approval.

**SECTION FOUR:** The publisher of the City of Hermann ordinances shall be permitted to re-designate the section or sub-section number of this revised code section to fit within an appropriate portion of the Hermann City Code, within the discretion of the publisher.
