AN ORDINANCE TO REVISE SCHEDULE VIII OF TITLE 3, TRAFFIC CODE, HANDICAPPED PARKING.

WHEREAS, the Board of Aldermen has determined that revising Schedule VIII, *Handicapped Parking*, to include new spaces as provided below would serve a legitimate public purpose and is in the best interests of the citizens of the City of Hermann, Missouri.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HERMANN, MISSOURI, AS FOLLOWS:

SECTION ONE: The following new locations shall be added to Schedule VIII, *Handicapped Parking*:

- 1. On the South side of the 100 block of East 5th Street, beginning at a point 10 feet West of the entrance to the City-owned parking area and continuing West 23 feet.
- 2. On the South side of the 100 block of East 5th Street, beginning at a point 10 feet East of the entrance to 116 East 5th Street and continuing East 23 feet.
- 3. On the West side of Market Street, beginning at a point 20 feet South of the South side of the alley adjacent to 408 Market Street and continuing 12 feet South, to create an angled handicapped parking space that is 12 feet wide and 23 feet long extending, generally, to the Northeast, in a manner consistent with the other parking spaces on Market Street.
- 4. On the West side of Gutenberg Street, beginning at a point 27 feet from the Southwest corner of the intersection of East 4th Street and Gutenberg Streets and continuing 12 feet South, to create an angled handicapped parking space that is 12 feet wide and 23 feet long extending, generally, to the Northeast, in a manner consistent with the other parking spaces on Gutenberg Street.

SECTION TWO: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION THREE: This Ordinance shall be in full force and effect from and after its passage and adoption.
