## ORDINANCE NUMBER 0-18-11

ORDINANCE AMENDING THE TOWNSHIP OF HILLSIDE TOWNSHIP CODE AT CHAPTER 261 (SOLID WASTE) ARTICLE I (Collection; Vehicle and Tire Storage; Weeds; Littering) OF THE "REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF HILLSIDE

WHEREAS, trash left out for a prolonged period of time is unsightly and a potential health hazard; and

WHEREAS, the Township has the power to from time to time establish and promulgate rules governing the rules removal and disposal of garbage to carry out the provisions of the Township Code; and

WHEREAS, the Any violation of such rules shall be subject to the penalties as provided in §261-28 of the Township Code

NOW THEREFORE BE IT ORDAINED, by the Township Council of the Township of Hillside, County of Union, State of New Jersey, as follows:

1. Section 3 Chapter 261 of the "Revised General Ordinance of the Township of Hillside, is hereby amended to read

Section 261-3- G. Storage and Can Location:

All receptacles containing solid waste or recyclables which are not being placed for collection or disposal shall be stored in such a manner as to minimize the potential negative impact upon the adjoining property owners. Their placement shall be reasonably inconspicuous from adjacent streets. Receptacles shall be stored at the rear of each private dwelling or in such a manner as to conceal same from the public view.

2. Section 7 Chapter 261 Preparation of Garbage for Storage and collection containers

All property owners, tenants or persons in possession are required to provide durable garbage containers minimum of 30 gallons and not more than 45 gallons equipped with portable or attached tops. One container per family/unit minimum. All newspapers and other paper material, including cardboard and cartons, shall be securely wrapped in bundles convenient for handling and so as to prevent separation and blowing about by the wind, and all cartons shall be broken down so as to be wrapped as flat pieces of cardboard. The use of paper cartons, baskets and wooden boxes in the disposal of garbage is prohibited. Durable plastic bags suitable for collection purposes only may

be used for overflow in addition to the required can. It shall be unlawful for any person to store or permit storage of any bulky household waste, except in a full receptacle or enclosure or during days designated for the collection of such items.

- 3. Section 28 Chapter 261 Violations and penalties
- A Any person found guilty of violating any provision of this chapter, for which a specific consequence for violations is not set forth herein, shall for (1) first offense be subject to a fine of \$250 \$50, with court costs, no court appearance required; (2) second offense; and (3) subsequent offenses be subject to a fine of not less than \$500 \$100 nor more than \$1,000, with court costs and a mandatory court appearance; or be subject to imprisonment for a term not exceeding 90 days or both.

AND BE IT FURTHER ORDAINED that all provisions of the Township of Hillside Code that are inconsistent with the provisions of this ordinance are repealed to the extent of such inconsistency.

- 2. Severability. Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase. If any portion of this Ordinance, or its application to any person or circumstances, shall be adjudged or otherwise determined to be invalid, unconstitutional, void, or ineffective for any cause or reason, such determination shall not affect the remaining provisions of this Ordinance, and the application of such remaining provisions shall not be affected thereby and shall remain in full force and effect, and to this end, the provisions of this Ordinance are severable.
- 3. Conflicts. This Ordinance is not meant to repeal any provisions of the Code, other than those specified herein above, but to add to its requirements, and all Ordinances or parts thereof inconsistent or in conflict with the provisions of this Ordinance are repealed only to the extent of such inconsistency or conflict.

This Ordinance shall take effect 20 days after final passage and publication as provided by law.
