ORDINANCE NUMBER O-20-14**

**AN ORDINANCE AMENDING BOND ORDINANCE APPROVED ON NOVEMBER 27, 2018 (O-18-19) TO REALLOCATE THE REMAINING BALANCE OF FUNDS SET FORTH IN SECTION 3(vii) REGARDING COMMUNITY CENTER EXPENDITURES**

**WHEREAS**, a bond ordinance was approved on November 27, 2018 providing for 2018 capital acquisitions, improvements and equipment for the Township of Hillside, in the County of Union, State of New Jersey (the “Township”); appropriating \$6,023,000 therefor and authorizing the issuance of \$5,734,000 bonds or notes of the Township to finance part of the costs thereof; and

**WHEREAS**, Section 3 (vii) sets forth an authorized expenditure for the William H. Buie Community Center for the purchase of a generator in the amount of \$325,000.00; and

**WHEREAS**, the generator has been installed at a of \$153,542.82, leaving a balance of \$171,457.18 which the Township desires to **reallocate** to the cost of the roof repair/replacement at the William H. Buie Community Center under a new sub-paragraph (ix).

**NOW THEREFORE BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF HILLSIDE, NEW JERSEY:**

Ordinance O-18-19 approved on November 7, 2018 is amended to read as follows:

**SECTION 3**

**(ix) Replacement of roof on the William Buie Community Center Appropriation: \$171,457.18.**

All other provisions of the Ordinance shall remain unchanged.

SECTION 12. This bond ordinance shall take effect twenty (20) days after the first publication hereof after final adoption, as provided by the Local Bond Law.


