

**MOTION FAILS  
TOWNSHIP OF HILLSIDE  
ORDINANCE O-23-03**

**ORDINANCE AMENDING CHAPTER 239-2 SCHEDULES OF FEES FOR COPIES OF  
GOVERNMENT RECORDS**

**WHEREAS**, New Jersey State Bill S3214 makes various revisions to requirements for obtaining a firearm purchaser identification card, permit to purchase a handgun, and permit to carry a handgun; codifies sensitive places in which firearms and destructive devices are prohibited.

**WHEREAS**, the Township of Hillside desires to amend Chapter 239-2 SCHEDULE OF FEES, Article 1, GOVERNMENT RECORDS, Section A. FIREARMS to comply with State Law.

**NOW THEREFORE BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF HILLSIDE THAT:**

1. CHAPTER 239-2 SCHEDULE OF FEES, Article 1, GOVERNMENT RECORDS, Section A. FIREARMS is hereby *amended* as follows:

**§ 239-2. Schedule of fees.**

The following fees shall be charged for copies of government documents:

**A. Firearms:**

1. Purchase permits: ~~\$2~~ **\$25** each.
2. Identification cards: ~~\$5~~ **\$50**.
3. Carry permits: ~~\$20~~ **\$150**.

**2. SEVERABILITY**

If any provision of this Ordinance, or the application of any such provision to any person or circumstances, shall be held invalid, the remainder of this Ordinance to the extent it can be given effect, or the application of such provision to persons or circumstances other than those to which it is held invalid shall not be affected thereby, and to this extent the provisions of this Ordinance are severable.

**3. REPEALER**

All ordinances or parts of ordinances which are inconsistent with any provisions of this Ordinance are hereby repealed as to the extent of such inconsistencies.

**4. EFFECTIVE DATE**

This Ordinance shall become effective twenty (20) days following the final adoption thereof by the Township Council of the Township of Hillside and shall be published as required by law.
