



**AN ORDINANCE AUTHORIZING AN EMERGENCY APPROPRIATION UNDER
N.J.S.A. 40A:4-53 FOR THE PURPOSE OF PREPARING A REVISION AND
CODIFICATION OF THE ORDINANCES OF THE TOWNSHIP OF HILLSIDE**

Be it ordained by the of Council of the Township of Hillside, County of Union, State of New Jersey as follows:

Section 1. Pursuant to N.J.S.A. 40A:4-53, the sum of \$20,500.00 is hereby appropriated for the purpose of the preparation of a revision and codification of the ordinances of the Township of Hillside and shall be deemed a special emergency appropriation as defined and provided for in N.J.S.A. 40A:4-55.

Section 2. The authorization to finance the appropriation shall be provided for in succeeding annual budgets by the inclusion of at least 1/5 of the amount authorized pursuant to this act (N.J.S.A. 40A:4-55).

Section 3. This ordinance shall take effect upon its passage, approval, publication and filing according to law.




