

AN ORDINANCE AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR AND CITY CLERK TO ENTER INTO AND EXECUTE ON BEHALF OF THE CITY OF HIGGINSVILLE, MISSOURI, A MEMORANDUM OF AGREEMENT BETWEEN THE CITY OF HIGGINSVILLE, MISSOURI, AND PIONEER TRAILS REGIONAL PLANNING COMMISSION, FOR SERVICES IN PREPARATION OF A FUNDING APPLICATION FOR A U.S. DEPARTMENT OF ENERGY, OFFICE OF CYBERSECURITY, ENERGY SECURITY, AND EMERGENCY RESPONSE (CESER) RURAL AND MUNICIPAL UTILITY CYBERSECURITY (RMUC) GRANT PROJECT, CONCERNING ELECTRICAL GENERATION AND DISTRIBUTION INFORMATION TECHNOLOGY NETWORK SYSTEMS, IN THE CITY OF HIGGINSVILLE, MISSOURI.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HIGGINSVILLE, MISSOURI, AS FOLLOWS:

Section 1. That the City Administrator and City Clerk are hereby authorized and directed to enter into and execute on behalf of the City of Higginsville, Missouri, a Memorandum of Agreement with Pioneer Trails Regional Planning Commission, 802 S. Gordon St., Concordia, Missouri, 64020, for services in preparation of a funding application for a U.S. Department of Energy, Office of Cybersecurity, Energy Security, and Emergency Response (CESER) Rural and Municipal Utility Cybersecurity (RMUC) Grant Project, concerning Electrical Generation and Distribution Information Technology Network Systems, in the City of Higginsville, Missouri, in accordance with the agreement attached hereto.

Section 2. This Ordinance shall take effect and be in full force from and after its passage.
