ORDINANCE NO. 02024-05-08

AN ORDINANCE AMENDING ORDINANCE NO. 02002-12-03. ESTABLISHING Α COMPREHENSIVE FEE SCHEDULE FOR REGULATING AND ASSESSING SERVICE CHARGES; PROVIDING FOR COLLECTION OF FEES; AMENDING DEPARTMENT 32. SANITATION SERVICES, BY ADJUSTING CERTAIN FEES AND ADDING ADDITIONAL FEES; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; CONTAINING A SEVERABILITY CLAUSE; AND PROVIDING FOR PUBLICATION AND AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Hillsboro, Texas entered into an agreement with Republic Services for solid waste disposal and recycling services on March 28, 2024; and

WHEREAS, Section 18 of this agreement included a provision for annual rate adjustments based on the Consumer Price Index for All Urban Consumers (Water, Sewer, and Trash Collection Services) U.S. City Average as published by the United States Department of Labor, Bureau of Statistics, for the most recently trailing 12-month average compared to the 12 months preceding the most recently 12 months; and

WHEREAS, Republic Services wishes to avail itself of this automatic annual increase in rates;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HILLSBORO, TEXAS, AS FOLLOWS:

<u>Section 1.</u> That Department 32, Sanitation Services, of Ordinance No. O2002-12-03, as amended, is hereby amended to read as provided for in Exhibit A, which is attached hereto and incorporated herein

<u>Section 2.</u> All ordinances or parts of ordinances and provisions of the Code of Ordinances, City of Hillsboro, inconsistent with or in conflict herewith are hereby repealed.

<u>Section 3.</u> If Any section, paragraph, subdivision, clause, phrase or provision of this ordinance shall be judge invalid or held unconstitutional, the same shall not in any amount be construed as to affect the validity of the remainder of this ordinance as a whole or any part or provision hereof, other than the parts so decided to be invalid or unconstitutional.

<u>Section 4.</u> This ordinance shall take effect after its passage and publication in an issue of the official newspaper of the City of Hillsboro, in accordance with the provisions of the laws of the State of Texas and the Charter of the City of Hillsboro, Texas.
