ORDINANCE 24-25

AN ORDINANCE OF THE TOWNSHIP OF HOWELL, COUNTY OF MONMOUTH, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 139 OF THE TOWNSHIP CODE ENTITLED "FEES"

NOW THEREFORE BE IT ORDAINED by the Mayor and Township Council of the

Township of Howell, County of Monmouth, State of New Jersey as follows:

NOTE: Sections of Chapter 139 that are to be amended by the within Ordinance for which

all *additions* are shown in *underlined bold italics*.

SECTION 1. Chapter 139 of the Township Code entitled "Fees" more specifically Article

XVI thereunder entitled "Housing Code; Rental Property" is hereby amended and

supplemented as follows:

§139-29. Certificates and inspections; returned checks.

Housing code fees shall be as follows:

- A. <u>A Residential Landlord Registration and Rental</u> <u>Certificate and inspection</u> shall be required every time there is a change of tenant, <u>owner, or yearly upon the</u> <u>expiration of the last issued rental certificate or</u> <u>landlord registration.</u>
 - (1) For structures constructed <u>in</u> 1978 or more recently: <u>\$250.</u>
 - (2) For structures constructed prior to 1978, the base fee shall be <u>\$250. An</u> additional \$75 surcharge will be assessed for the lead-based paint inspection and certification, when required, in accordance with New Jersey's Lead Safe Certificate Law (P.L. 2021, c. 182). Alternatively, a \$25 surcharge will be assessed for properties which utilize a third party lead safe or lead certification as authorized by Ch. 139-29.1D. Twenty dollars of the surcharge fees hereunder shall be deposited into the Lead Hazard Control Assistance Fund in accordance with the law.

- (3) For rental facilities containing multiple rental units, as defined by § 178-17, the fee for Landlord registration shall be \$100 per facility plus an additional per unit fee of \$150 for the residential rental certificate and inspection.
- (4) For any rental facilities or rental units designated as affordable housing pursuant to a Local, State, or Federal affordable housing program, the Landlord registration fee shall be \$100 for the entire property, consistent with § 139-29A(3), and the residential rental certificate and inspection fee shall be fifty percent (50%) of the amount set forth in § 139-29A(1), (2), or (3), as applicable.
- (5) For a rental facility partially composed of rental units designated as affordable housing pursuant to a Local, State, or Federal affordable housing program, the per-facility Landlord registration fee set forth in § 139-29A(3) shall remain unchanged, however, the per-unit rental certificate and inspection fee for such affordable housing rental units shall be fifty percent (50%) of the per-unit fee set forth in § 139-29A(3).
- <u>B.</u> <u>The third rental inspection, and every subsequent</u> <u>inspection thereafter, shall incur an additional fee of</u> <u>\$100 for each inspection.</u>
- C. There will be a fee of \$20 for all returned checks.

§139-29.1. Rental Housing Fees

Housing code fees shall as follows:

- A. An annual *landlord* registration fee *shall be included in the rental certificate application fee, except for multiunit rental facilities which shall be due January 1.*
- B. <u>Any change</u> in tenancy or <u>owner</u> during the certification period requires the issuance of a new <u>combined rental</u> certificate <u>and landlord registration</u>, <u>except for multiunit rental facilities which shall be due January 1. The</u> <u>fee shall be combined as part of the rental application</u> <u>per Chapter 139-29</u>, <u>except for except for multi-unit</u> <u>rental facilities which shall only pay the per-unit fee set</u> <u>forth in § 139-29A(3).</u>



- C. <u>The third rental inspection, and every subsequent</u> <u>inspection thereafter, shall incur an additional fee of</u> <u>\$100 for each such inspection in accordance with</u> <u>Chapter 139-29.</u>
- D. For a stand-alone lead-based paint inspection (not part of a rental certificate application) in accordance with the NJ Lead Safe Certificate Law (P.L. 2021, c. 182), the fee for inspection and certification shall be \$125. Twenty dollars of this fee shall be deposited into the Lead Hazard Control Assistance Fund in accordance with the law. <u>For</u> <u>properties providing third party lead safe or lead</u> <u>certification a \$25.00 fee shall be collected \$20.00 of</u> <u>which shall be deposited into the Lead Hazard Control Assistance Fund in accordance with the New Jersey's Lead Safe Certificate Law.</u>

SECTION 2. Chapter 139 of the Township Code entitled "Fees" more specifically Article XVIII thereunder entitled "Licenses and Permits (Miscellaneous)" is hereby amended and supplemented as follows:

§139-55. Property Registration Fees.

- A. <u>The landlord registration fee shall be included as part</u> of the rental application fee under Chapter 139-29 which is due annually one year from the date of the last registration. When a change of tenancy or ownership occurs within one year of the issuance of the rental certificate, the rental registration renewal date will reset to one year from the date of the issuance of the new rental certificate.
 - B. <u>Real/Vacant Property Registration Fees.</u>
 - (1) <u>Property in foreclosure: \$500.</u>
 - (2) <u>Vacant and/or abandoned property</u> <u>a.</u> <u>First year: \$1,000.</u>
 - <u>b.</u> <u>Second year and every year thereafter:</u> <u>\$2,000</u>
 - (3) <u>Property in foreclosure that is vacant</u>
 - a. First year: \$1,500.
 - b. <u>Second year and every year thereafter:</u> \$2,500.
 - (4) <u>Properties with multiple principal structures.</u> <u>Properties that are deemed vacant and abandoned</u> <u>as defined by Chapter 237 and also contain</u> <u>multiple principal structures shall incur an</u> <u>additional fee of \$500 per structure per year. This</u> <u>fee shall not be assessed for multiple tenant spaces</u> <u>within a single commercial building.</u>
 - (5) *Fire Bureau inspection discount.*

Any property owner that volunteers access to the interior portions of the property for the sole purpose of inspection by the Howell Township Fire Bureau in accordance with § 237-3H will receive a 50% discount off the first year's registration fee. To receive the discount, the property owner/responsible party must agree and execute an interior inspection of the property within 14 days of registration. The discount is only available for the first year's registration.
