# ORDINANCE CREATING CHAPTER 205 OF THE CODE OF THE TOWN OF HOLLAND, SHEBOYGAN COUNTY, WISCONSIN

**BE IT ORDAINED** by the Town Board of the Town of Holland, Sheboygan County, Wisconsin, that Chapter 205 of the Code of the Town of Holland is hereby created to read as follows:

#### **CHAPTER 205**

### Cigarettes, Electronic Vaping Devices, and Tobacco Products

### **Article I General Licensing Provisions**

#### § 205-1 License fees.

Fees for licenses issued under this chapter shall be set by the Town Board.

#### § 205-2 Definitions.

As used in this chapter, the following terms shall have the meanings indicated:

## LICENSE YEAR

The period from July 1 of each year to June 30 of the following year.

#### § 205-3 State statutes adopted.

The provisions of § 134.65, Wis. Stats., defining and regulating the sale and licensing of cigarettes, electronic vaping devices, and tobacco products, including the penalty provisions, are adopted and made a part of this chapter. Any future amendments, revisions, or modifications of the statutes incorporated in this chapter are intended to be made part of this chapter to maintain compliance with statewide regulation.

#### § 205-4 License required.

No person shall in any manner, or upon any pretense, or by any device, directly or indirectly sell, expose for sale, possess with intent to sell, exchange, barter, dispose of, or give away any cigarettes, electronic vaping devices, or tobacco products to any person not holding a license as herein provided without first obtaining a license from the Town Clerk.

## § 205-5 License application and fee.

Every person, firm, or corporation desiring a license under this chapter shall submit a written application, on the application forms prescribed by the State Department of Revenue or the Town, to the Town Clerk. Within 30 days of any change in any fact set forth in an application for a license under this chapter the applicant or licensee shall file a written description of the change with the Town Clerk. The annual fee prescribed for a license under this chapter, as set in the Town Fee Schedule, shall accompany the application.

## § 205-6 License issuance and terms.

Licenses for the sale, possession with intent to sell, exchange, barter, disposition of, or giving away of

cigarettes, electronic vaping devices, and tobacco products shall be issued by the Town Clerk. Unless earlier revoked, each license shall be effective commencing on the date of issuance or July 1 of the license year, whichever is later, through June 30 of the license year.

This Ordinance shall become effective upon passage and posting.
