**AN ORDINANCE EXTENDING THE MORATORIUM ON NEW TOBACCO  
LICENSES UNTIL JUNE 12, 2024**

WHEREAS, the Village of Homer Glen, Will County, Illinois (the “*Village*”) is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the “*Home Rule Powers*”); and,

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals, and welfare; and

WHEREAS, the Village deems it necessary to further extend the moratorium on new tobacco licenses established by Ordinance No. 23-056, and extended by Ordinance No. 24-014 and Ordinance No. 24-019 until June 12, 2024, during which time the Village shall continue to study and consider whether additional regulations for tobacco licenses in the Village are necessary in order to protect the health, safety, welfare and morals of the public.

NOW, THEREFORE, BE IT ORDAINED by the Village President and Village Board of Trustees of the Village of Homer Glen, Will County, Illinois, by and through its Home Rule Powers, as follows:

**Section 1. Incorporation of Recitals.** The above recitals are hereby declared to be true and correct and findings of the Village Board of the Village of Homer Glen and are incorporated herein.

**Section 2. Moratorium Extended.** That until June 12, 2024 from the effective date of this Ordinance, the moratorium on new tobacco licenses, under Chapter 83, Article III, of the Code of Ordinances of the Village of Homer Glen, is hereby extended. During the term of this moratorium, no new licenses for the sale of tobacco or tobacco products shall be issued by the Village, and no applications for the issuance of such licenses shall be processed.

**Section 3. Tobacco Sales.** All other provisions of the Code of Ordinances of the Village of Homer Glen applicable to Article III of Chapter 83 relating to the Sale of Tobacco and Tobacco products shall remain in full force and effect during the term of the moratorium extension by this Ordinance.

**Section 4. Severability.** If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this ordinance.

**Section 5. Repealer.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 6. Effective Date and Duration.** This ordinance shall be in full force and effect upon its passage, approval and publication as required by law.
