WHEREAS, ICE Allstars Blue Dynasty is a special needs competitive cheer team made up of seventeen athletes from ages 13 to 35, and 2 coaches and 5 dedicated buddies; and

WHEREAS, the team proudly represented the United States of America at the International Cheer Union ("ICU") World Championships in April, 2024 in the USA Cheer Special Olympics Traditional Category; and

WHEREAS, at the ICU World Championship the ICE Allstars Blue Dynasty participated in the opening ceremony, a cultural exchange, a showcase and then competed for two days, ultimately winning the **silver medal** for the United States; and

WHEREAS, the team also competed the National Cheer Association, U.S. All Star Federation competitions; winning all BOTH competitions and becoming the **NCA National Champions**, the **U.S. All Star Federation World Champions**; and

WHEREAS, the athletes competed and won the choreography and theme award for both titles; and

WHEREAS, ICE Allstars Blue Dynasty has completed an unprecedented regular Cheer season undefeated; and

WHEREAS, the Village President and the Board of Trustees recognize the dedication and teamwork as well as the many hours, weeks, and months that these young athletes and their coaches put into choreography, coordination, routines and practices; and
