AN ORDINANCE AMENDING THE HOPEWELL TOWNSHIP SEWER  
ORDINANCE, AND #19-10, CODIFIED AS ORDINANCE #7.04

**BE IT ORDAINED** by the Township Committee of the Township of Hopewell, County of Cumberland, and State of New Jersey, that the Sewer Ordinance of the Township of Hopewell is hereby amended and supplemented as follows:

SECTION 8. User Charges.

- A. No change
- B. Effective January 1, 2022, the annual rate for each domestic consumer unit (DCU) shall be \$750.00 Dollars, to be divided as follows: \$225.00 Dollars capital charge; \$525.00 Dollars treatment and operating charge. The rate shall be paid quarterly at the rate of one-fourth (1/4<sup>th</sup>) of the annual charge per quarter, and pro rata for portions thereof.


