**AN ORDINANCE AMENDING SECTION 289-8 (USER CHARGES) OF THE TOWNSHIP CODE**

**BE IT ORDAINED** by the Township Committee of the Township of Hopewell, County of Cumberland, and State of New Jersey, that the Sewer User Rate of the Township of Hopewell as is located in Section 289-8 of the Township Code is hereby amended and supplemented as follows:

SECTION 289-8: "User Charges"


- A. No change
- B. Effective January 1, 2024, the annual rate for each domestic consumer unit (DCU) shall be \$825.00 Dollars, to be divided as follows: \$225.00 Dollars capital charge; \$600.00 Dollars treatment and operating charge. The rate shall be paid quarterly at the rate of one-fourth (1/4<sup>th</sup>) of the annual charge per quarter, and pro rata for portions thereof.
