

ORDINANCE NO. 888

AN ORDINANCE OF THE BOROUGH OF HOPEWELL,  
COUNTY OF MERCER, NEW JERSEY, REGARDING  
PARKING AND AMENDING CHAPTERS 7 AND 7A OF "THE  
REVISED GENERAL ORDINANCES OF THE BOROUGH OF  
HOPEWELL, 1975"

BE IT ORDAINED by the Mayor and Council of the Borough of Hopewell, County of Mercer and State of New Jersey, as follows:

1. **Updates to Section 7-13, Mid-Block Crosswalks.** Section 7-13 of Chapter 7, entitled "Traffic," of the "The Revised General Ordinances of the Borough of Hopewell, 1975" ("Borough Code"), is hereby amended by removing West Broad Street as a designated location for a mid-block cross walk, and as follows (additions are underlined; deletions are [bracketed] and ~~struck~~):

**§ 7-13. MID-BLOCK CROSSWALKS.**

~~[The following described location is hereby amended as a mid-block crosswalk:~~

~~West Broad Street beginning 135 feet east of the easterly curb line of Mercer Street and extending 15 feet easterly thereof.]~~

2. **Updates to Section 7A-1, No Parking Schedule.** Section 7A-1 of Chapter 7A, entitled "Traffic Schedules," of the Borough Code, is hereby amended by removing reference to "no parking" on a portion of West Broad Street as follows, with no further changes to the remainder of section 7A-1 (additions are underlined; deletions are [bracketed] and ~~struck~~):

**§ 7A-1. SCHEDULE I: NO PARKING.**

In accordance with the provisions of subsection 7-3.3, no person shall park a vehicle at any time upon the following streets or parts of streets:

West Broad Street	North	For 100 feet west from Greenwood Avenue and for 100 feet east from Mercer Street
		For 50 feet west from Louellen Street and for 50 feet east from Louellen Street

		For 100 feet west from Greenwood Avenue


3. **Repealer.** All ordinances and resolutions or parts thereof inconsistent with this ordinance are repealed.


4. **Severability.** If any section, paragraph, subsection, clause or provision of this ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudged and the remainder of this ordinance shall be valid and enforceable.

5. **County Approval; Effective Date.** Following final passage and publication according to law, this ordinance shall be submitted to the Board of County Commissioners of the County of Mercer. The provisions of this ordinance shall not go into effect until and unless the Board has consented to the provisions of this ordinance.
