THE TOWN BOARD, having held a public hearing on the 12th day of December, 2023 at 2:00 p.m. to consider adopting Local Law Introductory No. 44-2023 amending the Uniform Traffic Code of the Town of Huntington, Chapter 2, Article IV, §2-7, Schedule G, and due deliberation having been had; and

WHEREAS, the installation of stop signs is a Type II action pursuant to 6 N.Y.C.R.R 617.5(c)(22) and, therefore, no further review is required.

HEREBY ADOPTS

Section 1. Amendment to the Uniform Traffic Code of the Town of Huntington, Chapter 2, Article IV, §2-7, Schedule G; as follows:
