RESOLUTION NO. R-2024-097

RESOLUTION CANVASSING RETURNS ORDERING AND DECLARING THE RESULTS OF THE SPECIAL ELECTION TO CONSIDER SIXTEEN CHARTER AMENDMENTS TO THE HUTTO CITY CHARTER PROVIDING FOR VOTING TOTALS AND RESULTS OF THE CITY OF HUTTO'S SPECIAL ELECTION OF MAY 4, 2024; PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, by Ordinance No.O-2024-012, passed and approved and adopted by the City Council of the City of Hutto ordered a special election to be held May 4, 2024 for the purpose of submitting to voters sixteen (16) proposed amendments to the Home Rule Charter of the City of Hutto, Texas; and

WHEREAS, the City Council has investigated all matters pertaining to the election, including the ordering, giving notice, officers, holding, and making returns of the election; and

WHEREAS, the election officers who held the election have duly made the returns of the result thereof, and the returns have been duly delivered to the City Council; and

WHEREAS, a quorum of the City Council met on Wednesday, May 15, 2024 in public meeting duly called and conducted in accordance with the Texas Open Meetings Act and duly canvassed the election returns of the Special Election of the sixteen (16) Charter Amendments to the Hutto Home Rule Charter.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HUTTO, TEXAS:

<u>Section 1</u>: The findings set forth in the recitals of this Resolution are hereby found to be true and correct and are hereby adopted as findings of the City Council and are incorporated into the body of this Resolution as if fully set forth herein.

Section 2: That the City Council officially finds and determines that the election was duly ordered, the proper notice of the election was duly given, that proper election officers were duly appointed prior to the election, that the election was duly held in the manner required by law, that due returns of the result of the election have been made and delivered, and that the City Council has duly canvassed the returns, all in accordance with the law and the ordinances and resolutions calling and conducting the election.

<u>Section 3</u>: The official Canvass of the Returns of the Special Election on Charter Amendments held May 4, 2024 reflects the following Propositions received the number of FOR votes and AGAINST votes respective to that proposition:

Shall SECTION 3.04 COMPENSATION of the Hutto City Charter be amended to replace the word "compensation" with salary and add that the salary is subject to the limitation imposed by state law and Texas Constitution?

<u>Section 4</u>: That pursuant to the applicable provisions of the Texas Local Government Code, the Texas Election Code and the Hutto Home Rule Charter, the City Council officially finds. determines and declares the result of the election to be that Propositions, A, B, C, E, F, G, H, I, J, K, L, M, N, O, and P have been approved by the majority of the qualified voters of the City of Hutto, Texas who voted in the Charter Amendment Special Election and that said amendments are adopted by operation of law as required by Texas Local Government Code Section 9.005(a).

<u>Section 5</u>: That pursuant to the applicable provisions of the Texas Local Government Code, the Texas Election Code and the Hutto Home Rule Charter, the City Council officially finds. determines and declares the result of the election to be that Proposition D has not been approved by the majority of the qualified voters of the City of Hutto, Texas who voted in the Charter Amendment Special Election.

<u>Section 6</u>: That this Order declares the Charter Amendments adopted shall take effect upon the passage of this resolution, as provided by Texas Local Government Code Section 9.005(a) and the Home Rule Charter of the City of Hutto, Texas, as amended, Attachment "A", is incorporated, herein, for all purposes.

<u>Section 7</u>: It is further ordered that Mayor shall certify to the Texas Secretary of State an authenticated copy of the Hutto Home Rule Charter, with Charter Amendments under the City of Hutto seal showing approval by the voters of the City of Hutto, Texas, who shall then file and record the certification as required by the Texas Local Government Code Section 9.007.

<u>Section 8</u>: That the Interim City Secretary shall record in the City Secretary's office the Chater Amendments adopted by the voters of the City of Hutto, Texas.

<u>Section 9</u>: That the provisions of this Resolution are severable, and in case any one or more of the provisions hereof or the application thereof to any person or circumstance should be held to be invalid. unconstitutional, or ineffective as to any person or circumstance then the remainder of this Resolution nevertheless shall be valid and the application of any such invalid provision to persons or circumstances other than those as to which it is held invalid shall not be affected thereby.

Section 10: The City Council hereby finds and declares that written notice of the date, hour, place and subject of the meeting at which this Resolution was adopted was posted and that such meeting was open to the public as required by law at all times during which this Resolution and the subject matter hereof were discussed, considered and formally acted upon, all as required by the Open Meetings Act, Chapter 551, Texas Government Code, as amended.

Section 11. This Resolution shall take effect immediately upon its passage.
