## SIDEWALK SPECIFICATIONS

- Generally, the sidewalks must meet the minimum requirements established by the Indiana Borough sidewalk ordinance and other governing regulations (e.g. ADA requirements). Sidewalks must be a minimum of four (4) feet wide.
- 2. 3500# cement mix with fiber and C-grade fly-ash.
- 3. Two (2) rows of a minimum diameter of ½ inch re-bar must be installed and the length of the sidewalk with rebar cross braces tied a minimum of eight (8) feet along the length of the sidewalk to be poured.
- 4. When two (2) ends of rebar meet, they must overlap a minimum of 18 inches and tied at both ends.
- 5. Rebar chairs must be used to hold the two rows of rebar in the bottom third of the sidewalk being poured.
- 6. Expansion joints placed at all corner crossings, other sidewalks, driveways, and other fixed points.
- 7. A minimum of four (4) inches of 2B grade aggregate shall be placed under the concrete.
- 8. All sidewalks must be a minimum of four (4) inches thick. Driveway sections and all ADA compliant ramps must be a minimum of six (6) inches thick.
- 9. Truncated domes must be installed at sidewalks and intersecting streets.
- 10. Sidewalk must be sealed with a penetrating sealer.
- 11. After removal of the forms, the affected areas adjacent to the sidewalk must be filled with topsoil and seeded.
- 12. An inspection must be performed by the department of Planning & Code Enforcement after the form and prior to the pour.
