AN ORDINANCE TO AMEND CHAPTER 397 ARTICLE I. NOISE REGULATIONS SECTION 397-4 A (1) PERMITS FOR USE OF LOUDSPEAKERS AND AMPLIFIERS ALLOWING A PERMIT TO BE ISSUED.

An Ordinance Amending Chapter 397 Article I Section 397-4A (1) Permits for Use of Loudspeakers and Amplifiers allowing a Permit to be issued of the Township of Irvington.

BE IT ORDAINED by the Municipal Council of the Township of Irvington as follows: Chapter 397-4A(1) is hereby amended to read as follows:

- The permits shall specify the dates and hours of the permitted use and activity, which shall not be permitted before the hour of 10:00 a.m. nor after 8:00 p.m. and not permitted on Sundays or religious holidays, except if the holiday is on a Monday and same is in direct connection with a specific celebration or parade.

NOW, THEREFORE BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON AS FOLLOWS:

SECTION 1. Chapter 397 Article I Noise Regulations Section 397-4 A (1) Permits for Use of Loudspeakers and Amplifiers Allowing a Permit to be Issued of the Revised Code of the Township of Irvington is hereby amended to permit the use of Loudspeakers and amplifiers on Sundays or religious holidays if the holiday is on a Monday and same is in direct connection with a specific celebration or parade.

SECTION 2. All sections of the Revised Code of the Township of Irvington that are inconsistent or in conflict with the provisions of this Ordinance are hereby repealed to the extent of their inconsistencies.

SECTION 3. This Ordinance shall take effect upon final passage and publication according to law.
