Chapter 158. Alcoholic Beverages

Article I. In General

§ 158-3. Hours of sale.

- A. No retail licensee for Consumption (31, 32 or 33) shall sell or serve any alcoholic beverages before 9:00 a.m. and 2:00 a.m. on Monday, Tuesday, Wednesday, Thursday, Friday or Saturday, nor before 12:00 noon and 2:00 a.m. on Sunday. Further, on New Year's Eve, the licensee may remain open an additional three hours from 2:00 a.m. to 5:00 a.m. Also, please note that the hours mentioned refer to Eastern Standard Time or daylight saving time, whichever time shall be then in effect and shall apply hereto.
- B. By A.B.C. regulation (N.J.A.C. 13:2-38), no retail licensee may sell spirituous liquors in original containers [Distribution (44) package goods] before 9:00 a.m. and after 10:00 p.m. on any day of the week.
