

**ORDINANCE NO. 2026-19**

**ORDINANCE OF THE TOWNSHIP OF JACKSON,  
COUNTY OF OCEAN, STATE OF NEW JERSEY,  
CONFIRMING THE VACATION OF A PORTION OF  
CERTAIN RIGHTS OF WAYS AND PAPER STREETS  
LOCATED WITHIN JACKSON TOWNSHIP, OCEAN  
COUNTY, NEW JERSEY**

**BE IT ORDAINED** by the Township Council of the Township of Jackson, County of Ocean, State of New Jersey, as follows:

**SECTION 1. Purpose.** The Township of Jackson has previously vacated certain paper streets located within the municipality. It is the intention of this Ordinance to ensure that Ordinance No. 16-73 is clarified to note that the Township did intend then, and does now, to vacate any and all remaining portions of Farwell Street, Delta Avenue, and Gregory Street which may not have been fully vacated by the Township of Jackson in 1973.

**SECTION 2.** Pursuant to Ordinance 16-73 the Township Committee of the Township of Jackson intended to vacate all right, title and interest of the public in portions of various paper streets throughout the Township including Farwell Street, Delta Avenue and Gregory Street for the benefit of the Jackson Board of Education. By the adoption of this Ordinance the Township of Jackson hereby declares that it has previously intended, and does pursuant to this Ordinance, vacate all of the right, title and interest of the public in all portions of Farwell Street, Delta Avenue and Gregory Street.


**SECTION 3.** The public rights and interests are hereby vacated with respect to the above noted right of ways and paper streets.

**SECTION 4. Severability.** The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby.

**SECTION 5.** Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

**SECTION 6. Effective Date.** This Ordinance shall take effect upon publication in the official newspaper of the Township of Jackson, as required by and in conformance with law.
