### RESOLUTIONS

1. RESOLVED, That Sergeant Jason Donato and Detective Floyd Kent be and they hereby are authorized to attend the Fire Science Evidence Collection Training in Montour Falls, New York, May 21-23, 2014 with expenses paid pursuant to Section 77-b of the General Municipal Laws of the State of New York. Police Chief/Director of Public Safety Harry Snellings stated that this is the first time for this training. Sergeant Donato is an arson investigator and Detective Kent is our evidence tech and crime scene guy. We want to get them both certified so they can handle evidence from fire scenes.

Mr. Lombardi stated there is an interest end a little earlier. The stunt show has gone until 9-9:30 P.M. Crowds have decreased based on the time. The idea is to end earlier this year and have good connections set-up with other downtown venues so that people can filter into other things to do downtown.

Councilman Whitford stated you are going to advertise it for people to get there early?

Mr. Lombardi stated yes. The idea is to get families there earlier and have activities for people to go to. This will assist businesses after 8 P.M.
