James Slagle, Hotel Jamestown Building, 110 W. 3rd St.: I ask the Council again about these manhole covers. It's costing everybody in the City new tires and new lineups every year because your manholes are so deep when the wheel hits it it just knocks the

heck out of the car. Is there a possibility that you could put more blacktop in them, or do something? They don't have to be that deep – there are some worse than that, especially on Foote Avenue. My front wheel hits that one everytime I go by it. It's mostly right out in the middle of the road and they need to be looked in to. Again, I'm talking about the Cherry Street Parking Ramp. The lights up there are getting terrible. They're not staying lit. There's one up there that what makes it go, it's been out for almost a year and I don't know...Jeff – what are you going to do about these lights up there? They're not staying lit, there are ones that have been out for year.

Mr. Lehman: I'll let you know.

Mr. Slagle: It's just not safe. Now you've got the Spring Street Parking Ramp parking over there too and they're coming in early in the morning – half of them are out. You put bulbs in them and they don't last. It's just getting out of hand and again, I want to commend Chief Rater on his Police Department – they're doing a good job in the City. I've asked him to go down on Cherry Street side and have his men at night, late at night, by the Hotel Jamestown because they're sleeping in there. We have no security in there at all and thank you very much.

Peter Morgante, 134 Euclid Avenue: Tonight you've got six. Last time I came here there was five; at a work session there was seven; tonight you've got six. I said a long time ago you've got to reorganize – perhaps we don't need a Mayor anymore. We need a City Manager made up of Council people and somebody who is interested in the affairs of this City. How can we run our City with people who aren't even here. This is ridiculous. We have issues going around in the City and nobody shows up. People come here – nobody listens. We pay attention because you don't listen to people you don't care what they think – it seems that way. Even Mr. Szwejbka was on the radio show. Nobody has any comments or any faith in our City Council in our City government anymore because nobody even comes to the meetings. We had a big issue with this traffic issue. Another child got injured today on North Main Street and nothing seems to be done but you can't stop accidents. And putting new signs and more signs up is not going to help the child who does not read them on the accidents. Something is wrong with our streets in our City and the traffic patterns. We've got more traffic streets – speedways – Falconer Street, Buffalo Street, 2nd Street, Fifth Street, Seventh, Sixth – all over the City and it's terrible. And we see more and more accidents and our Chief has got them. He sees the reports and nothing seems to be done in order to stop the accidents. Some how or another, something has to be done but we need somebody on Council where people can hear and listen to the people.

Councilwoman Ecklund: Normally, I don't like to comment to some of the things that Mr. Morgante has addressed tonight, but there are certain things that people should be aware of. In addition, just a couple other comments I would like to make is (1) for everyone to keep in mind that we have a BPU meeting to be held at Love School next Thursday, so for any Councilpersons in the community to come out is the next round of meetings regarding the Clean Coal Power Plant Project. In addition, I just wanted to mention, also off of what Mr. Morgante had said that this City Council, I know, has taken the series of tragedies and unfortunate traffic accidents seriously. We had discussed weeks ago about examining the traffic patterns on Falconer Street, about getting the speed trailer to examine the speeds and the traffic volume as well and I thank the Department for doing that and to continue to please do that as well. Just to let the community know that at the same time, we're doing all we can to try to make these roads safer and for whatever reason, there is a series of these unfortunate accidents that seem to be happening quite often, more so than we've ever really known. But at the same time, just a reminder to parents, to please be careful –

watch the kids. Make sure things are safe. Memorial Day Weekend is coming up. Traffic does get a little crazy there so especially with the long weekend coming, be extra careful with your families, with your children; and the final note I want to make is there are a lot of activities and things going on in the Jamestown area – downtown – for Memorial Day Weekend, and for everyone to be sure to support those during these economic times.
