

ORDINANCE O-07-2026

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF JACKSBORO, TEXAS, AMENDING CHAPTER 11. TRAFFIC AND VEHICLES, ARTICLES 11.07 TRAFFIC SCHEDULES, SECTION 11.07.002 "ONE-WAY STREETS", REESTABLISHING NORTH FOURTH STREET FROM WEST LIVE OAK TO WEST COLLEGE AS A TWO-WAY STREET; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Jacksboro may adopt traffic regulations controlling the movement of vehicles on public roads within its corporate limits in accordance with the Texas Transportation Code; and

WHEREAS, the City Council has determined that traffic regulation is necessary for the health, safety and general welfare of the children and community who live, work and travel on North Fourth Street between West Live Oak and West College streets; and

WHEREAS, Chapter 11, Traffic and Vehicles, Article 11.07 Traffic Schedules documents the various traffic schedules established by Ordinance of the City Council as follows:

- 11.07.001 SCHEDULE 1: Four-way stops.**
- 11.07.002 SCHEDULE II: One-way streets.**
- 11.07.003 SCHEDULE III: Speed limits.**
- 11.07.004 SCHEDULE IV: Truck routes.**
- 11.07.005 SCHEDULE V: U-turns prohibited.**
- 11.07.006 SCHEDULE VI: School zones.**
- 11.07.007 SCHEDULE VII: Stop intersections.**

WHEREAS, the City Council has determined that it is in the best interest of the health, safety and general welfare of the public to amend Section 11.07.002 SCHEDULE II: One-way streets of the Code of Ordinances and repeal the designation of a one-way direction on North Fourth Street, between West College and West Live Oak streets; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JACKSBORO, TEXAS, THAT:

SECTION 1. All of the above premises are hereby found to be true and correct and are hereby approved and incorporated into the body of this ordinance as if copied in their entirety.

SECTION 2. Chapter 11, Traffic and Vehicles of the City of Jacksboro Code of Ordinances is hereby amended relative to Section 11.07.002 SCHEDULE II: One-way streets, as set forth in the attached "Attachment A".

SECTION 3. REPEALING CLAUSE. All provisions of the Code of Ordinances of the City of Jacksboro, Texas, in conflict with the provisions of this Ordinance, be, and the same are hereby, repealed, and all other provisions not in conflict with the provisions of this Ordinance shall remain in full force and affect.

SECTION 4. SEVERABILITY. It is declared to be the intent of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this ordinance are severable, and if any phrase, clause, sentence, paragraph, or section of this Ordinance is declared invalid by the judgment or decree of a court of competent jurisdiction, the invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this Ordinance since the city council would have enacted them without the invalid portion.

SECTION 5. EFFECTIVE DATE. This ordinance shall take effect immediately after the removal of "One-Way" signs by the street superintendent, as designated by Section 11.04.027 of the Code of Ordinances.

§ 11.07.002. Schedule II: One-way streets. The following streets, or portions of streets, are hereby designated as one-way streets and all traffic on such streets shall, during the times given, move only in the direction given or the direction posted on such streets:
