1 AN ORDINANCE TO AUTHORIZE AN AMENDMENT OF THE 2024 2 BUDGET PURSUANT TO THE HOME RULE CHARTER OF JEFFERSON 3 COUNTY, MISSOURI, AND SECTION 50.622 RSMO (2023) TO REFLECT THE TRANSFER OF BUDGET FUNDS BETWEEN THE LAW ENFORCEMENT 4 5 RESERVE ACCOUNT AND LAW ENFORCEMENT RESERVE REVENUE 6 ACCOUNT. 7 WHEREAS, the Sheriff's Division, Lt. Col. Timothy Whitney, requests that funds 8 in the amount of Thirty Thousand Dollars (\$30,000.00) be transferred from the Law 9 Enforcement Reserve Account, (215-9999-1015) to the Law Enforcement Reserve 10 Revenue Account, (215-9999-4002) to be used for the purpose of and in addition to the 11 grant funds received from Mo. Dept of Health and Senior Services to replace the Jail 12 Camera System critical for the safety and welfare of inmates and staff; and 13 WHEREAS, Article VII, Section 7.2.10 of the Home Rule Charter of Jefferson 14 County, Missouri, provides that if during the fiscal year the County Executive certifies that 15 there are revenues available for appropriation in excess of those estimated in the budget, 16 the County Council by Ordinance may make supplemental appropriations for the year up to the amount of such excess; and 17

1	WHEREAS, Article VII, Section 7.2.13 of the Home Rule Charter of Jefferson
2	County, Missouri, permits the Jefferson Missouri, Council to transfer unencumbered funds
3	or balances within a Department; and
4	WHEREAS, both the County Executive and Auditor have certified that funds are
5	available for the proposed appropriation set forth herein; and
6	WHEREAS, the Sheriff's Division, Lt. Col. Timothy Whitney, requests that funds
7	in the amount of Thirty Thousand Dollars (\$30,000.00) be transferred from the Law
8	Enforcement Reserve Account, (215-9999-1015) to the Law Enforcement Reserve
9	Revenue Account, (215-9999-4002) to be allocated to the Law Enforcement Fund, Sheriff
10	Division, Other Capital Equipment (215-0387-5690) for the purpose of replacing the Jail
11	Camera System; and
12	WHEREAS, the Auditor of Jefferson County approves of this budget amendment.
13	BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,
14	AS FOLLOWS:
15	Section 1. The Budget of Law Enforcement for Jefferson County, Missouri, subject
16	to any and all budget limitations, shall be amended to reflect the excess funds available by
17	appropriating and transferring funds based upon certification of the County Executive as
18	follows: Thirty Thousand Dollars (\$30,000.00) be transferred from the Law Enforcement
19	Reserve Account, (215-9999-1015) to the Law Enforcement Reserve Revenue Account,
20	(215-9999-4002) to be allocated to the Law Enforcement Fund, Sheriff Division, Other
21	Capital Equipment (215-0387-5690) for the purpose of replacing the Jail Camera System

- Section 2. The amounts in this Budget Amendment Ordinance shall only be used 1 for the purposes, accounts and account strings as identified herein and for no other purpose. 2 3 This Ordinance shall be in full force and effect from and after its Section 3.
