| 7 | WHEREAS, Jefferson County, Missouri ("County") has received additional |
| 8 | unanticipated revenue in the amount of One Hundred Fifty Six Thousand, Nine Hundred |
| 9 | and Forty Dollars (\$156,940.00) from the Missouri Department of Health and Senior |
| 10 | Services; and |
| 11 | WHEREAS, said additional funds will be placed in the Law Enforcement Fund, |
| 12 | Sheriff Division, Grant, Detection and Mitigation in Confinement Facilities (215-0380- |
| 13 | 4300-0191). These funds were not included in the original submission of the 2024 budget; |

| 15 | WHEREAS, Section 50.622 RSMO (2023) and the Home Rule Charter of |
| 16 | Jefferson County, Missouri, permits a budget amendment to appropriate receipt of |
| 17 | additional funds not included at the time of budget adoption; and |

| 1 | WHEREAS, the Jail Division will use this funding to replace the jail camera |

| 7 | WHEREAS, the Auditor of Jefferson County approves of this budget amendment; |

| 10 | Sections 7.2.10 and 7.2.12, the County Executive of Jefferson County recommends and |
| 11 | certifies, by the submission of this Bill, that there will be revenues available for the budget |
| 12 | amendment and appropriations therefrom for the use of the funds set forth herein during |
| 13 | the Fiscal Year 2024 received under the aforementioned distribution and therefore, request |
| 14 | that the Council take the necessary actions as set forth herein and requests that the |
| 15 | necessary budget amendments and appropriations be made in accordance with this |
| 16 | legislation and further advises the Council that the same is proper and necessary; and |
| 17 | WHEREAS, it is the best interest of the County to approve this budget amendment |
| 18 | and appropriate the funds accordingly to the Law Enforcement Fund, Jail Division, Other |
