1	AN ORDINANCE TO AUTHORIZE THE COUNTY EXECUTIVE TO
2	EXECUTE CHANGE ORDER NO. 1 FOR THE REBID PARK PAVILION
3	KIMMSWICK CONTRACT FOR THE JEFFERSON COUNTY, MISSOURI,
4	DEPARTMENT OF PARKS AND RECREATION.
5	WHEREAS, Pursuant to Ordinance 23-0278, Jefferson County, Missouri and the
6	Department of Parks and Recreation entered into a Contract, known as the Rebid Park
7	Pavilion Kimmswick Contract, with Integra, Inc., for \$176,925.00 per term; and,
8	WHEREAS, the Department of Parks and Recreation of Jefferson County, Missouri
9	finds that it is now necessary to adjust the estimated amount of the Rebid Park Pavilion
10	Kimmswick Contract; and
11	WHEREAS, the need for the adjustment is due to there being soil issues upon where
12	the pavilion will be located; and
13	WHEREAS, mitigation will be to remove the poor soils and replace with 1 minus
14	rock at a depth of 2 foot to give a solid base to construct the pavilion; and
15	WHEREAS, Jefferson County, Missouri and the Department of Parks and
16	Recreation for Jefferson County, hereby request an increase of an additional Twelve
17	Thousand, Nine Hundred Thirty-Six Dollars (\$12,936.00) to the Rebid Park Pavilion with
18	Integra, Inc.; and,

1	WHEREAS Jefferson County, Missouri, Council finds that it is now necessary and
2	in the best interest of the County to execute Change Order No. 1 to the Rebid Park Pavilion
3	Kimmswick Contract with Integra, Inc., for an increase of Twelve Thousand, Nine Hundred
4	Thirty-Six Dollars (\$12,936.00) to the contract sum, subject to budgetary limitations; for a
5	revised total of One Hundred Seventy Thousand Dollars (\$189,861.00) for the Rebid Park
6	Pavilion Kimmswick Contract upon approval.
	BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,
	AS FOLLOWS:
7	Section 1. The Contract with Integra, Inc., for the Rebid Park Pavilion
8	Kimmswick Contract shall be increased by Twelve Thousand, Nine Hundred Thirty-Six
9	Dollars (\$12,936.00) for a revised total cost of One Hundred Seventy Thousand Dollars
10	(\$189,861.00) subject to budgetary limitations.
11	Section 2. The Jefferson County, Missouri, Council hereby authorizes the County
12	Executive to execute Change Order No. 1 to the Rebid Park Pavilion Kimmswick Contract
13	with Integra, Inc., and any agreements or contracts necessary to effectuate the award of the
14	bids and proposals set forth in this Ordinance. The County Executive is further authorized to
15	take any and all actions necessary to carry out the intent of this Ordinance.
16	Section 3. Copies of all Invitations for Bid, response thereto, any contract
17	agreements and change orders shall be maintained by the Department of the County Clerk
18	consistent with the rules and procedures for the maintenance and retention of records as

promulgated by the Secretary of State.

- 1 Section 4. This Ordinance shall be in full force and effect from and after its date
- 2 of approval. If any part of this Ordinance is invalid for any reason, such invalidity shall not
- 3 affect the remainder of this Ordinance.


