ORDINANCE NO. 2024 - 02

AN ORDINANCE OF THE BOROUGH OF JIM THORPE,  
CARBON COUNTY, COMMONWEALTH OF PENNSYLVANIA  
AMENDING THE VEHICLE AND TRAFFIC ORDINANCE FOR  
THE BOROUGH OF JIM THORPE.

WHEREAS, the Borough of Jim Thorpe has adopted a Borough Code including Chapter 420 regarding Vehicles and Traffic; and,

WHEREAS, the Borough Council wishes to amend said Ordinance.

NOW THEREFORE, the Borough Council of Jim Thorpe Borough hereby enacts and ordains as follows:

1. Section 420-12 shall be amended and restated as follows:

LOCATION: a) Beginning at Quarry Street eastward along the south side of Broadway to Spring Street, and from Spring Street along both sides of Broadway and Market Square to Susquehanna Street; on Hazard Square along the east side, north side, and a portion of the west side; along the east side and west side of Susquehanna Street from Broadway to the Mansion House Hill.

- LOCATION:**
- b) Between designated parking signs along Lehigh Avenue.
  - c) At designated parking areas along the southside of Broadway in the area of 65 Broadway
  - d) At designated parking area on the north side of High Street.
  - e) At designated parking areas on the north side of West Broadway near the Stabin Gallery/Museum.

RATE:	CASH DISCOUNT RATE:	MAXIMUM PARKING TIME: (Hours)
2.00 per hour (and any part thereof)	1.50 per hour (and any part thereof)	5hrs

Persons who have obtained residential parking permits per Article X below shall be permitted to park in items d) and e) above without the use of the parking kiosk. Further, persons using the parking kiosk in items d) and e) above shall only be permitted to use the kiosk, through the kiosk system, Monday through Friday (excluding national legal holidays) from 9:00 a.m. to 6:00 p.m.

The rates established above are for the periods of Monday, Tuesday, Wednesday, and Thursday. The rate on Friday, Saturday and Sunday and holidays shall be rate of \$2.50 per hour or any part thereof and cash discount rate of \$2.00 per hour and any part thereof.

The parking rates established above in this Section 420-12 may be amended from time to time by resolution of Borough Council.

**2. Section 420-13 (A) shall be amended and hereinafter read as follows:**

- A. Parking kiosks shall be operated by the deposit of currency, credit card or other approved manners of payment as set forth in § 420-16 below, and the parking rates for specified lengths of time as well as the maximum parking times, prescribed in § 420-12, shall apply at all times

between the hours of 9:00 a.m. and 6:00 p.m. seven days a week in the parking kiosk zones listed in § 420-12.

3. **Section 420-29.2** A new Section 420-29.2 shall be added and should read as follows:

420-29.2 Local Streets. The Borough of Jim Thorpe does hereby designate the following streets as local roads:

- A. Packer Hill Road.
- B. Hill Road
- C. Race Street
- D. High Street


4. **Section 420-29.1 (B)** A new Section 420-29.1(B) shall be added and shall read as follows:

420-29.1(B) Right Turns. Drivers shall be prohibited from making a right hand turn from Packer Hill onto Hazard Square.

In all other respects this Ordinance shall remain the same.
