**ORDINANCE TO ADOPT AMENDMENTS TO THE  
VILLAGE OF JOHNSON CREEK COMPREHENSIVE PLAN**

---

THE VILLAGE BOARD OF THE VILLAGE OF JOHNSON CREEK, JEFFERSON COUNTY, WISCONSIN, DOES ORDAIN AS FOLLOWS:

SECTION 1:

**WHEREAS**, pursuant to sections 61.35 and 62.23(2) and (3) of Wisconsin Statutes, the Village of Johnson Creek is authorized to prepare and adopt a comprehensive plan as defined in sections 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes; and

**WHEREAS**, the Village Board adopted its comprehensive plan on September 26, 2017 entitled “Village of Johnson Creek Comprehensive Plan”; and

**WHEREAS**, as part of the Village’s original adoption of a comprehensive plan the Village Board adopted and has since followed written procedures designed to foster public participation in every stage of the preparation of a comprehensive plan as required by §66.1001(4)(a) of the Wisconsin Statutes; and

**WHEREAS**, the Plan Commission of the Village of Johnson Creek, by a majority vote of the entire Commission recorded in its official minutes, has adopted a resolution recommending to the Village Board the approval of amendments to the Comprehensive Plan Future Land Use Map which involve changing the land use designations for two parcels. The proposed amendments to the Future Land Use Map are described and attached hereto and incorporated by reference as Exhibit A; and,

**WHEREAS**, the Village of Johnson Creek has, in compliance with the requirements of section 66.1001(4)(d) of the Wisconsin Statutes, provided opportunities for public involvement per its adopted public participation plan; and

**WHEREAS**, the Village Board held a public hearing on the proposed amendments on November 13, 2023, considered the public comments made and the recommendations of the Plan Commission and staff, and has determined to approve the recommended amendments.

**NOW, THEREFORE**, the Village Board of Johnson Creek, Wisconsin, does ordain that the proposed amendments are hereby approved as amendments to the Village’s Comprehensive Plan pursuant to section 66.1001(4)(c) of Wisconsin Statutes.


SECTION 2: All ordinances or parts of ordinances conflicting with or contravening the provisions of this Ordinance are hereby repealed.
