ORDINANCE NO. 1583-2024

AN ORDINANCE AMENDING ORDINANCE NO. 1517-2023 AND THE CITY CODE SECTION 700 AND SECTION 720 OF THE CITY OF KEARNEY, MISSOURI, PRESCRIBING THE AMOUNT TO BE CHARGED TO CUSTOMERS FOR WATER AND SEWER SERVICES.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF KEARNEY, MISSOURI, AS FOLLOWS:

Section 1. Section 700.110.A. and B. of the City Codification is hereby amended and replaced with new rates, as follows:

SECTION 700.110. Water User Charges-Customers Connected to Both Water and Sewer Systems

A. The monthly rates required and which shall be charged and collected by the City of Kearney, Missouri, for water and water service furnished by the waterworks system of the City of Kearney, Missouri, shall be as follows:

Meter Size	Monthly Water Service Charge:
5/8" X 3/4"	\$5.00
1"	\$9.00
2"	\$17.50
4"	\$60.00

\$11.27 – 1,000 gallons minimum, plus above respective service charge
 \$0.982 per 100 gallons (1,000-2,000 gallons)
~~\$0.881~~ 1.103 per 100 gallons - all over 2,000 gallons

For City Senior Residents over the age of sixty-five (65) having a water account in their name, a \$4.00 per month credit shall be given on said monthly service charge upon notification of the Water Department.

The aforesaid amounts to be charged for water and water service do not include the Missouri State Sales Tax, and such tax shall be computed and added thereto.

B. Customers outside the City limits of Kearney shall pay an additional 100% of the applicable user charge fee and connection fee.

Section 2. Section 700.130.A. and B. of the City Codification is hereby amended and replaced with new rates, as follows:

SECTION 700.130. Sewer User Charges-Customers Connected to Both Water and Sewer Systems

A. The monthly rates required and which shall be charged and collected by the City of Kearney, Missouri, for sewer and sewer service furnished by the sewerage system of the City of Kearney, Missouri, shall be as follows:

1"	\$9.00
2"	\$17.50
4"	\$60.00

\$12.55 - 1,000 gallons minimum, plus above respective service charge
 \$0.798 per 100 gallons (1,000-2,000 gallons)

For City Senior Residents over the age of sixty-five (65) having a sewer account in their name, a \$4.00 per month credit shall be given on said monthly service charge upon notification of the Water Department.

~~The aforesaid amounts to be charged for water and water service and sewage service do not include the Missouri State Sales Tax, and such tax shall be computed and added thereto.~~

B. Customers outside the City limits of Kearney shall pay an additional one hundred percent 100% of the applicable user charge fee.

Section 3. Section 700.135.A. and B. of the City Codification is hereby amended and replaced with new rates, as follows:

SECTION 700.135. Sewer User Charges - Sewer Only Customers

A. The monthly rate required and which shall be charged and collected by the City of Kearney, Missouri, for sewer and sewer service furnished by the sewerage system of the City of Kearney, Missouri, shall be as follows:

SEWER USER CHARGE--SEWER ONLY CUSTOMERS

Minimum Charge: \$ 75.37 for up to 1,000 gallons
 \$ 0.798 per 100 gallons (1,000-2,000 gallons)
~~\$0.709~~ 0.936 per 100 gallons all over 2,000 gallons

Flat Sewer Charge when no meter readings are available: ~~\$118.94~~ 157.00 per month

The aforesaid amounts to be charged for sewer and sewerage service do not include the Missouri State Sales Tax, and such tax shall be computed and added thereto.

B. Customers outside the City limits of Kearney shall pay an additional 100% of the applicable user charge fee.

Section 4 Section 720.040 E. of the City Codification is hereby amended and replaced with new rates, as follows:

SECTION 720.040 USER CHARGE RATES

E. The rate schedule with operation, maintenance and replacement plus bond cost shall be ~~as the user charges established in Chapter 700 Water and Sewer Service, Article III Water and Sewer Rates~~ follows:

Section 5. That the aforesaid amounts to be charged for water and sewer service do not include Missouri State Sales Tax, and such tax shall be computed and added thereto.

Section 6. Ordinance No. 1517-2023 and all other ordinances or parts of ordinance in conflict herewith are hereby repealed.

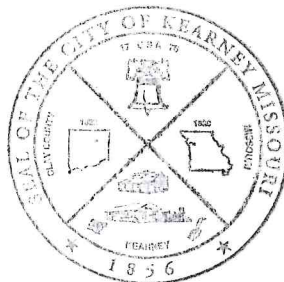
Section 7. This ordinance shall be in full force and effect from and after the date of passage and shall remain in effect until amended or repealed by the Board of Aldermen.

Section 1. Section 700.110.A. and B. of the City Codification is hereby amended and replaced with new rates, as follows:

SECTION 700.110. Water User Charges-Customers Connected to Both Water and Sewer Systems

A. The monthly rates required and which shall be charged and collected by the City of Kearney, Missouri, for water and water service furnished by the waterworks system of the City of Kearney, Missouri, shall be as follows:

\$11.27 – 1,000 gallons minimum, plus above respective service charge
\$0.982 per 100 gallons (1,000-2,000 gallons)
\$1.103 per 100 gallons - all over 2,000 gallons

For City Senior Residents over the age of sixty-five (65) having a water account in their name, a \$4.00 per month credit shall be given on said monthly service charge upon notification of the Water Department.

The aforesaid amounts to be charged for water and water service do not include the Missouri State Sales Tax, and such tax shall be computed and added thereto.

B. Customers outside the City limits of Kearney shall pay an additional 100% of the applicable user charge fee and connection fee.

Section 2. Section 700.130.A. and B. of the City Codification is hereby amended and replaced with new rates, as follows:

SECTION 700.130. Sewer User Charges-Customers Connected to Both Water and Sewer Systems

A. The monthly rates required and which shall be charged and collected by the City of Kearney, Missouri, for sewer and sewer service furnished by the sewerage system of the City of Kearney, Missouri, shall be as follows:

\$12.55 - 1,000 gallons minimum, plus above respective service charge
 \$0.798 per 100 gallons (1,000-2,000 gallons)
 \$0.936 per 100 gallons-all over 2,000 gallons

For City Senior Residents over the age of sixty-five (65) having a sewer account in their name, a \$4.00 per month credit shall be given on said monthly service charge upon notification of the Water Department.

- B. Customers outside the City limits of Kearney shall pay an additional one hundred percent 100% of the applicable user charge fee.

Section 3. Section 700.135.A. and B. of the City Codification is hereby amended and replaced with new rates, as follows:

SECTION 700.135. Sewer User Charges - Sewer Only Customers

- A. The monthly rate required and which shall be charged and collected by the City of Kearney, Missouri, for sewer and sewer service furnished by the sewerage system of the City of Kearney, Missouri, shall be as follows:

SEWER USER CHARGE--SEWER ONLY CUSTOMERS

Minimum Charge: \$ 75.37 for up to 1,000 gallons
 \$ 0.798 per 100 gallons (1,000-2,000 gallons)
 \$0.936 per 100 gallons all over 2,000 gallons

Flat Sewer Charge when no meter readings are available: \$157.00 per month

The aforesaid amounts to be charged for sewer and sewerage service do not include the Missouri State Sales Tax, and such tax shall be computed and added thereto.

- B. Customers outside the City limits of Kearney shall pay an additional 100% of the applicable user charge fee.

Section. 4 Section 720.040 E. of the City Codification is hereby amended and replaced with new rates, as follows:

SECTION 720.040 USER CHARGE RATES

E. The rate schedule with operation, maintenance and replacement plus bond cost shall be the user charges established in Chapter 700 Water and Sewer Service, Article III Water and Sewer Rates

Section 5. That the aforesaid amounts to be charged for water and sewer service do not include Missouri State Sales Tax, and such tax shall be computed and added thereto.

Section 6. Ordinance No. 1517-2023 and all other ordinances or parts of ordinance in conflict herewith are hereby repealed.

Section 7. This ordinance shall be in full force and effect from and after the date of passage and shall remain in effect until amended or repealed by the Board of Aldermen.

Section 8. Should any section, clause or provision of these regulations be declared invalid or unconstitutional by any court of competent jurisdiction, the same shall not affect the validity of these regulations as a whole, or any part thereof, other than the part so declared invalid or unconstitutional.
