## BILL NO. 30-2024

AN ORDINANCE APPROVING A FINANCIAL ASSISTANCE AGREEMENT WITH THE MISSOURI DEPARTMENT OF NATURAL RESOURCES FOR A LAND AND WATER CONSERVATION FUND GRANT IN THE AMOUNT OF \$504,653.

**WHEREAS,** Resolution 53-2002 authorized the City Administrator to sign documents associated with the Hall Park; and

WHEREAS, On October 5, 2023, the City conducted a public open house and feedback session regarding the proposed plans for Hall Park and submitted an application to the Missouri Department of Natural Resources for a grant to construct Hall Park; and

**WHEREAS,** The FY 2025 City of Keaney approved budget has funds allocated specifically for the Hall Park project.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF KEARNEY, MISSOURI, AS FOLLOWS:

**Section 1.** The Mayor is authorized to sign the Missouri Department of Natural Resources Financial Assistance Agreement in the amount of \$504,653.00.

**Section 2.** This ordinance shall be in full force and effect on after passage by the Board of Aldermen and approval by the Mayor.
