ORDINANCE #21-19

ORDINANCE OF THE BOROUGH OF KEYPORT, COUNTY OF MONMOUTH, NEW JERSEY, AMENDING CHAPTER VII (TRAFFIC) SECTION 7-12 (HANDICAPPED PARKING) AND SCHEDULE XXI (PARKING AREA FOR HANDICAPPED PERSONS) OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF KEYPORT REGARDING 91 CHURCH STREET

WHEREAS, the Borough of Keyport (the "Borough") is a public body corporate and politic of the State of New Jersey; and

WHEREAS, the Revised General Ordinances of the Borough (the "Code") currently list the streets and locations of designated handicapped parking spaces within the Borough; and

WHEREAS, the Borough has determined that a handicapped parking space directly across from a certain private residence in the Borough located at 91 Church Street (the "Residence") pursuant to *N.J.S.A.* 39:4-197.6; and

WHEREAS, the Council of the Borough (the "Council") has determined to amend Subchapter 7-12 (Handicapped Parking) of the Code and Schedule XXI (Parking Area for Handicapped Persons) referenced therein to add the designated restricted parking space in front of the Residence.

NOW THEREFORE, BE IT ORDAINED by the Council of the Borough of Keyport, County of Monmouth, New Jersey that:

1. The aforementioned recitals are incorporated herein as though fully set forth at length.

2. The Council hereby amends Subchapter 7-12 and Schedule XXI of the Code to read as follows:

7-12 Handicapped Parking.

Pursuant to the authority granted to the municipality by N.J.S.A. 39:4-197, the locations described in Schedule XXI are hereby designated as restricted parking spaces for use by persons who have been issued special vehicle identification cards by the Motor Vehicle Commission. No other person shall be permitted to park in this space.

SCHEDULE XXI PARKING AREA FOR HANDICAPPED PERSONS

In accordance with Section 7-12, and pursuant to the authority granted to the municipality by N.J.S.A. 39:4-197, the following locations are hereby designated as restricted parking spaces for use by persons who have been issued special vehicle identification cards by the Division of Motor Vehicles. No other person shall be permitted to park in this space.

Atlantic Street

Beginning at a point 88 feet south of the southerly curbline of Maple Place and continuing 25 feet south therefrom.

Burtina Street	North- east	40 feet from the northeast corner of the intersection of Burtina Street and Hurley Street.
Burtina Street	North- west	40 feet from the northwest corner of the intersection of Burtina Street and Hurley Street.
Church Street	West	Beginning at a point 217 feet south of the southerly curbline of East Front Street and continuing 25 feet south therefrom.
<u>Church Street</u>	<u>West</u>	Measuring the distance from the prolongation of the lateral curb line, the distance from the corner of Third Street in a southerly direction, to the beginning of the handicapped parking space will be one hundred ninety-six and seven tenths (196.7) feet. From that point, the handicapped parking space will be twenty (20) feet for the total distance of two hundred sixteen and seven tenths (216.7) feet.
Hurley Street	North	40 feet west from the northwest corner of the intersection of Hurley Street and Green Grove Avenue.
Main Street	East	Beginning at a point 100 feet north of the northerly curb line of Third Street and continuing 26 feet north therefrom.
Main Street	West	Beginning at a point 168 feet south of the southerly curbline of Front Street to a point 20 feet southerly therefrom.
Main Street	South- east	20 feet from the southeast corner of the intersection of Main Street and Jackson Street.
Maple Place	South	Beginning at a point 31 feet west of the westerly curbline of Van Dorn Street and extending to a point 22 feet west thereof.
Warren Street	North- west	40 feet from the northwest corner of the intersection of Warren Street and Division Street.
West Third Street	North	Measuring the distance from the prolongation of the lateral curb line, the distance from the corner of Broad Street in a westerly direction, to the beginning of the handicapped parking space will be ninety-eight (98) feet. From that point, the handicapped parking space will be twenty (20) feet for the total distance of one hundred eighteen feet (118)

Williamson Street	South .	Beginning at a point 474 feet east of the easterly curbline of Green Grove Avenue and continuing 25 feet east therefrom.
Williamson Street	South	Beginning at a point 317 feet east of the easterly curbline of Green Grove Avenue and continuing 25 feet east therefrom.

Section 3. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed.

Section 4. Each section, subsection, sentence, clause and phrase of this ordinance is declared to be an independent section, subsection, sentence, clause and phrase and the finding or holding of any such portion of this ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this ordinance.

Section 5. Except as amended by this ordinance, all other provision of the Borough's Revised General Ordinances shall remain in full force and effect.

Section 6. The Borough Clerk is hereby directed, upon adoption of the ordinance after public hearing thereon, to publish notice of the passage thereof.

Section 7. This ordinance shall be in full force and effect from and after its adoption and any publication according to law.
