

ORDINANCE # 1701

AN ORDINANCE AMENDING CHAPTER IV (GENERAL LICENSING AND BUSINESS REGULATIONS), SECTION 4-2.9 (COMPLIANCE WITH HEALTH REQUIREMENTS) OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF KEANSBURG.

Section 1:

BE IT ORDAINED by the Mayor and Council of the Borough of Keansburg that Chapter IV (General Licensing and Business Regulation), Section 4-2.9 (Compliance with Health Requirements) of the Revised General Ordinances be amended as follows:

Section 4-2.9 Compliance with Health Requirements

ADD

a. *Registration; License Fees.*

Health License Fee Schedule

Retail establishments selling only prepackaged foods	\$25.00 annually
Seasonal Food establishments	\$50.00 annually
Year-Round Food establishments, Food Distributors, Food Product Manufacturers	\$100.00 annually

- b. Licenses expire on December 31st of each calendar year.
- c. On or after March 31st of each year a penalty fee will be charged of twenty-five (\$25.00) dollars for last registration which is paid after that date.

Section 2: REPEALER. The remainder of all other sections and subsections of the aforementioned ordinance not specifically amended by this Ordinance shall remain in full force and effect.

Section 3: INCONSISTENT ORDINANCES. All Ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed as to such inconsistency.

Section 4: SEVERABILITY. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of this ordinance shall be deemed valid and effective.

Section 5: EFFECTIVE DATE. This ordinance shall take effect upon its passage and publication according to law.

AN ORDINANCE AMENDING CHAPTER IV (GENERAL LICENSING AND BUSINESS REGULATIONS), SECTION 4-2.9 (COMPLIANCE WITH HEALTH REQUIREMENTS) OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF KEANSBURG.

Section 1:

BE IT ORDAINED by the Mayor and Council of the Borough of Keansburg that Chapter IV (General Licensing and Business Regulation), Section 4-2.9 (Compliance with Health Requirements) of the Revised General Ordinances be amended as follows:

Section 4-2.9 Compliance with Health Requirements

SECTION 1

Shall read as follows:

- a. Registration; License Fees.
Health License Fee Schedule

- Retail establishments selling only prepackaged foods \$25.00 annually
- Seasonal Food establishments \$50.00 annually
- Year-Round Food establishments, Food Distributors, Food Product Manufacturers \$100.00 annually
- b. Licenses expire on December 31st of each calendar year.
- c. On or after March 31st of each year a penalty fee will be charged of twenty-five (\$25.00) dollars for last registration which is paid after that date.

Section 2: REPEALER. The remainder of all other sections and subsections of the aforementioned ordinance not specifically amended by this Ordinance shall remain in full force and effect.

Section 3: INCONSISTENT ORDINANCES. All Ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed as to such inconsistency.

Section 4: SEVERABILITY. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of this ordinance shall be deemed valid and effective.

Section 5: EFFECTIVE DATE. This ordinance shall take effect upon its passage and publication according to law.
