LOCAL LAW 1 OF 2026 OF THE COMMON COUNCIL OF THE CITY OF KINGSTON, NEW YORK, AMENDING ETHICS SECTION 49-5 (C) OF THE CODE OF THE CITY OF KINGSTON

WHEREAS, under Local Law 1 of 2025, the City of Kingston adopted Section 49 Ethics of the Code of the City of Kingston; and

WHEREAS, Section 5-C of the Code is entitled Annual Disclosure; and

WHEREAS, the proposed edit is in the best interests of the City of Kingston.

NOW THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF KINGSTON, NEW YORK AS FOLLOWS:

SECTION 1. The purpose of this Local Law is to amend Section 49-5 (C) of the Code of the City of Kingston by adding the following role to the list of employees who must file Annual Disclosure Forms:

Municipal Business Liaison (a/k/a City of Kingston Business Liaison)

SECTION 2. If any provisions of this local law are held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, the remaining provisions of the local law shall remain in effect.

SECTION 3. This local law shall take effect upon filing with the Secretary of State.
