Proposed Local Law No. 1 of the year 2023

A local law amending Chapter 172 of the Town of Kinderhook Code

Be it enacted by the Town Board of the _____

PURPOSE AND INTENT

The Town Board of the Town of Kinderhook hereby adopts amendments to Chapter 172 of the Town of Kinderhook Code in order to regulate use of the Town Park and recreation areas within the Town in a manner that promotes public health, welfare and safety.

AUTHORIZATION

The Town Board of the Town of Kinderhook enacts this Local Law under the authority granted by:

1. Article IX of the New York State Constitution, §2(c) (6) and (10).
2. New York Municipal Home Rule Law §10.

ENACTMENT

Be it enacted by the Town Board for the Town of Kinderhook that Chapter 172 of the Kinderhook Town Code be hereby amended as follows:

§172-9 Hunting Prohibited.

It shall be unlawful to engage in any type of hunting, including but not limited to any hunting involving a bow, shotgun, and/or rifle, upon the Town Park, playgrounds or recreation areas.

§172-10 Penalty for Offenses.

A violation of this chapter shall constitute a violation as defined in the Penal Law and shall be punishable by a fine of not more than \$250 or by imprisonment for not more than 15 days, or both.

SEVERABILITY

In the event that any word, phrase or part of this local law shall be declared unconstitutional, the same shall be severed and separated from the remainder of this local law and shall not effect the remainder of said local law which shall remain in full force and effect.

EFFECTIVE DATE

This Local Law shall take effect immediately upon filing in the Office of the New York State Secretary of State.


