ORDINANCE 10871

AN ORDINANCE AMENDING THE KIRKWOOD CODE OF ORDINANCES, CHAPTER 14, ARTICLE VIII., SECTION 14-401 "ONE-WAY STREETS", TO ADD ARGONNE ALLEY AS A ONE-WAY ALLEY BETWEEN THE EAST PROPERTY LINE OF 114 WEST JEFFERSON AND CLAY AVENUE IN THE WESTBOUND DIRECTION.

WHEREAS, the Street Code Issues Team (SCIT) received a request from residents and businesses that the Argonne Alley be designated as one-way, and

WHEREAS, Argonne Alley is between Argonne Boulevard to the south, Clay Avenue to the west, and has a spur to the north with parking to Jefferson Avenue, and

WHEREAS, the portion with parking between Jefferson Avenue and the alley is codified as one-way to the south, the rest of the alley is open to two-way traffic, and

WHEREAS, SCIT has reviewed the request and recommends that Chapter 14, Article VIII., Section 14-401 "One-way streets" should be amended to add Argonne Alley as a one-way alley between Clay Avenue and the east property line of 114 West Jefferson in the westbound direction.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF KIRKWOOD, MISSOURI, AS FOLLOWS:

SECTION 1. The Kirkwood Code of Ordinances, Chapter 14, Article VIII., Section 14-401 "One-way streets" is hereby amended as follows:

§ 14-401. One-way streets.

No person shall operate a motor vehicle upon the following streets and alleys, except in the direction indicated:

Alley between Jefferson and Argonne Drive, 100 block east	Southbound
Argonne Alley, between Clay Avenue and the east property line of 114 West Jefferson	Westbound
Argonne Drive, 100 block east and 100 block west	Divided street
Briargate Lane	West
Erber Drive	North
Huntleigh, from Kirkwood Road to the intersection of Timbercrest, Woodridge	East
Longview	Divided street
Manchester Way	Northwest
Ponca Trail	East
School Lane, from Edgewood to Kirkwood Road	West

SECTION 2. This Ordinance shall be in full force and effect after its passage and approval, as provided by law.

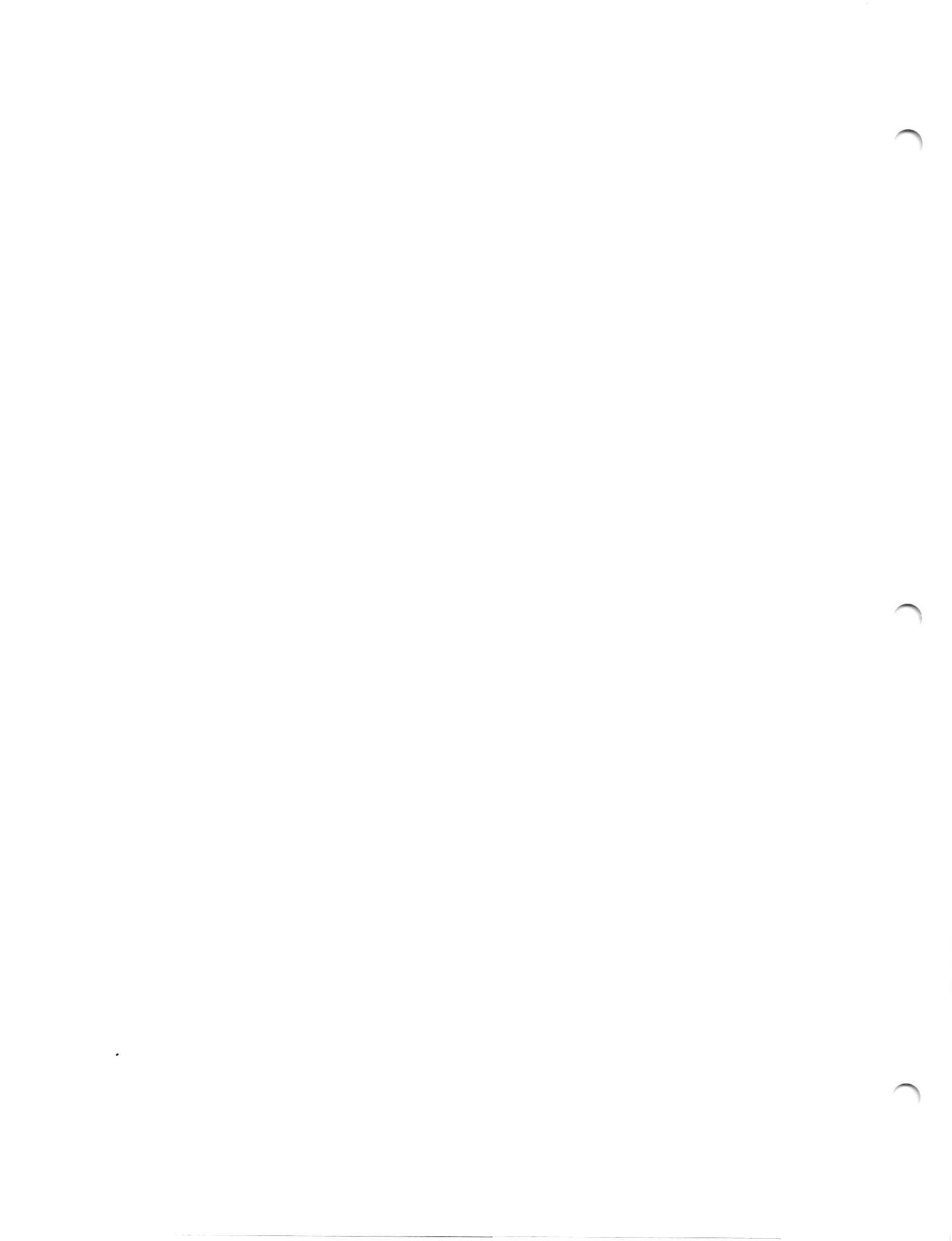

Goal # & Title Goal 1. Enhance the quality of life of citizens

Background To Issue:

SCIT received several inquiries from residents and businesses requesting that the Argonne Alley be designated as one-way. Argonne Alley is between Argonne Boulevard to the south, Clay Avenue to the west, and has a spur to the north with parking to Jefferson Avenue. The portion with parking between Jefferson Avenue and the alley is codified and signed as one way to the south. The rest of the alley is open to two-way traffic. SCIT reviewed the request. SCIT has observed that the alley is not wide enough for two-way traffic between Clay Avenue and the Jefferson Spur. SCIT reached out to the Downtown Kirkwood SBD to poll business owners on the one-way designation and if businesses had a preference on the proposed one way direction of Argonne Alley. Based on input received from the SBD and SCIT it is recommended that Argonne Alley between Clay Avenue and the east property line of 114 W Jefferson be made one-way westbound only. Therefore, traffic entering from Clay Avenue would be prohibited. SCIT recommends one way in the westbound direction, as this would eliminate turning movement conflicts on Clay Avenue.

Recommendations and Action Requested:

SCIT recommends approval of Argonne Alley as a one-way alley between the east property line of 114 W Jefferson and Clay Avenue in the westbound direction by adding code language "Alley between Clay Avenue and the East property line of 114 W Jefferson, West", in Chapter 14 Motor Vehicles and Traffic, Article VIII Traffic Schedules, Section 401 One-way streets.
