THE FOLLOWING RESOLUTION WAS OFFERED
BY COUNCIL MEMBER STUDLEY, WHO

WHEREAS, the Municipal Home Rule Law of the State of New York and Chapter 26 of the Code of the Town of Lancaster provide for the adoption and enactment of local laws; and

WHEREAS, a proposed ordinance to amend Part II – General Legislation, Chapter 350 – Vehicle and Traffic Ordinance, Article IX, Section 350-12 of the Code of the Town of Lancaster, County of Erie, State of New York was introduced to the Town Board of the Town of Lancaster by Council Member Studley; and

WHEREAS, the Town Board, acting as Lead Agency under the State Environmental Quality Review Act (“SEQRA”) has determined the action is a Type I action and has issued a negative declaration; and

WHEREAS, the Town Board called for, noticed, and held a public hearing on the proposed Amendment on May 6, 2024, where all interested parties were allowed to address the proposed Amendment.

NOW, THEREFORE,

BE IT RESOLVED, by the Town Board of the Town of Lancaster

that:

1. The attached Amendment to the Vehicle and Traffic Ordinance is hereby adopted.
2. That said Amendment be added in the Minutes of the meeting of the Town Board of the Town of Lancaster held on June 3, 2024.
3. That a Certified Copy thereof be published in the Lancaster Bee as soon as practicable.
4. That a Certified Copy of the Amendment be posted on the Town Bulletin Board.
5. That Affidavits of Publication and Posting be filed with the Town Clerk.
6. That the Highway Superintendent take whatever action is necessary to install signs in accordance with the Law.

NOTICE OF ADOPTION
AMENDMENT TO VEHICLE AND TRAFFIC ORDINANCE
TOWN OF LANCASTER, COUNTY OF ERIE, STATE OF NEW YORK
DESIGNATED AS CHAPTER 350 OF THE CODE OF THE TOWN OF LANCASTER**

NOTICE IS HEREBY GIVEN that the Vehicle and Traffic Ordinance of the Town of Lancaster, Erie County, New York, designated as Chapter 350 of the Code of the Town of Lancaster, is hereby amended as follows:

**Part II: General Legislation
Chapter 350: Vehicles and Traffic
Article IX: Speed Regulations
Section 350-12: Maximum Speed Limits]**

§350-12(E) A speed limit of 30 miles per hour shall be posted on the following designated highways:

ADD

(10) Warner Road for Northbound and Southbound traffic from Pleasant View Drive to Green Meadow Drive.

ADD

(11) Stutzman Road for Eastbound, Westbound, Northbound and Southbound traffic between Genesee Street and Pleasant View Drive.
