**Be it enacted** by the Board of Trustees of the Village of Lake George ("Village"), County of Warren, State of New York ("State") as follows:

### Section 1. Legislative Intent.

Local Law Filing

The Board of Trustees hereby finds and determines that it is in the best interests of the Village to repeal §34-6 of Chapter 34 of the Code of the Village of Lake George.

Section 2. Repeal of §34-6 of Chapter 34 of the Code of the Village of Lake George.

§34-6 of Chapter 34 of the Code of the Village of Lake George is hereby repealed.

#### Section 3. Severability.

If any clause, sentence, paragraph, subdivision, section, or part of this Local Law or the application thereof to any person, individual, corporation, firm, partnership, entity, or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its

operation to the clause, sentence, paragraph, subdivision, section, or part of this Local Law, or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

### Section 4. Effective Date.

This Local Law shall take effect immediately upon filing with the New York State Secretary of State.
