

ORDINANCE #2024 - 10

**ORDINANCE OF THE TOWNSHIP OF LACEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AN ORDINANCE ENTITLED "AN ORDINANCE OF THE TOWNSHIP OF LACEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AFFIXING AND DETERMINING THE SALARIES, WAGES AND COMPENSATION OF THE OFFICERS, EMPLOYEES AND MEMBERS OF THE GOVERNING BODY OF THE TOWNSHIP"**

**BE IT ORDAINED** by the Township Committee of the Township of Lacey, County of Ocean, State of New Jersey, as follows:

**SECTION 1.** Section 1 of the salary ordinance shall be amended to reflect the following wages for the following officers, employees and members of the governing body of the Township of Lacey:

**SECTION 2.** Any salary, wage or compensation not hereinbefore mentioned shall remain the same hereto before.

**SECTION 3.** The salaries, wages, and other compensation listed in Section 1A and 1B above shall be retroactive and payable from May 20, 2024 or the date of employment, whichever is the latter.

**SECTION 4.** All ordinances or parts of ordinance inconsistent herewith are hereby repealed.

**SECTION 5.** This ordinance shall take effect after second reading and publication as required by law. The salaries listed above cannot be paid until 20 days has lapsed after the second reading publication.
