

ORDINANCE NO. 2026-10

AN ORDINANCE OF THE TOWNSHIP OF LACEY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 261 OF THE TOWNSHIP CODE OF THE TOWNSHIP OF LACEY, ENTITLED "PARKS"

SECTION 1. Chapter 261 of the Township Code of the Township of Lacey, entitled "Parks," is hereby amended and supplemented so as amend various sections as follows:

§ 261-13 – C(5) Swimming

(5) No person over the age of five years shall use any of said bathing beaches without first paying a license fee of \$10 for each year, for which there shall be issued to him or her a badge. Said badge at all times shall be worn by any person using any of the bathing or beach facilities and shall be displayed and exhibited upon request by any police officer or by any other authorized person.

§261-13-10(b)

(b) The operating season will be determined by the Township of Lacey Recreation Department each season. The inflatable floating playground will operate daily within the operating season of the Lacey Township Beach Patrol. The hours of operation will be listed below with the exception of inclement weather. The Township of Lacey Recreation Department may alter these times base on staffing levels, maintenance requirements, and/or accommodate extraordinary circumstances.

10:30 AM – 11:15 AM Reserved for Group Sales/Open to the Public if nothing is booked

11:30 AM – 12:15 PM Reserved for Group Sales/Open to the Public if nothing is booked

12:45 PM – 1:30 PM Open to the Public

2:00 PM – 2:45 PM Open to the Public

3:00 PM – 3:45 PM Open to the Public

4:30 PM – 6:00 PM Reserved for Group Sales/Open to the Public if nothing is booked

§261-13-10(c)

(c) The following Fee Schedule is set forth herein

[1] A session wristband is \$10 for a current Lacey Township Beach Patrol license holder (beach badge). If you do not possess a license the session wristband is \$20.

[2] To book a group you must have a minimum of 25 people. A group of 25 will be \$225 and \$9 per person for each person after 25 for a current Lacey Township Beach Patrol license holder (beach badge). If you do not possess a license, a group of 25 is \$475 and \$19 per person for each person after 25.

§261-38. Summer recreation program.

The Director of the Township Recreation Department may conduct a Children's Summer Recreation Program at Township parks. Said program is to be conducted in accordance with rules and regulations established by the Recreation Director. The program may be attended by children from the age of five (5) to thirteen (13), Monday through Friday, 9:00 a.m. to 3:00 p.m. The fee for attendance is \$200.00 child prior to the first day of camp, and is payable at registration. (The fee covers camp registration for the season, 4 T-shirts and the season end party) The fee for attendance upon the first day of camp and thereafter is \$250.00 and is payable at registration.

SECTION 3. Chapter 261 of the Township Code of the Township of Lacey, entitled "Parks," is hereby amended and supplemented so as to create a new S 261-38, entitled "Summer recreation program," which shall read in its entirety as follows:

§261-38. Summer recreation program.

The Director of the Township Recreation Department may conduct a Children's Summer Recreation Program at Township parks. Said program is to be conducted in accordance with rules and regulations established by the Recreation Director. The program may be attended by children from the age of five (5) to thirteen (13), Monday through Friday, 9:00 a.m. to 3:00 p.m. The fee for attendance is \$200.00 child, and is payable at registration. (The fee covers camp registration for the season, 4 T-shirts and the season end party)

SECTION 4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 5. If any section, subsection, sentence, clause, phrase or portion of this

ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 6. This ordinance shall take effect after second reading and publication as required by law.
