Local Law #6-2023

A local law amending Chapter 150. Solid Waste, Article II, Storage and Accumulation; Litter and Debris & Chapter 127. Rental Regulations of the Code of the Village of Lake Grove.

§150-12. Definitions.

AUTHORIZED PRIVATE RECEPTACLE

A litter storage and collection container which is durable, rest-resisting and has a tight-fitting cover; receptacles used for the storage of garbage shall in addition thereto be nonabsorbent and watertight and shall not exceed 30 gallons in capacity. (a plastic bag is not an acceptable container)

§150-19. Garbage containers.

All garbage containers shall be covered securely at all times. Following collection, garbage containers shall be placed at the rear of the house or building of the owner or occupant and shall not be stored upon the street, sidewalk, or other public place. Plastic bags with household garbage must be placed in containers (Authorized private receptacles) when put out for pickup.

Chapter 127. RENTAL REGULATIONS

127-2. Eligibility to rent property.

The owner of a real property in the Village of Lake Grove³ shall have owned and used the property as their primary residence for a period of not less than five continuous years before the owner shall be eligible for a rental permit and to rent that property. Renting individual rooms and renting for less than one (1) year of time is prohibited.


