A Local Law #2-2024 - Amending Chapter 38. Procurement Policy of the Code of the Village of Lake Grove

§ 38-1. Review of purchase type; competitive bidding; documentation.

A. Every purchase to be made must be initially reviewed to determine whether it is a purchase contract or a public works contract. Once that determination is made, a good faith effort will be made to determine whether it is known or can reasonably be expected that the aggregate amount to be spent on the item of supply or service is not subject to competitive bidding, taking into account past purchases and the aggregate amount to be spent in a year. The following items are not subject to competitive bidding pursuant to § 103 of the General Municipal Law; purchase contracts under [\$10,000] \$20,000 and public works contracts under [\$20,000] \$35,000; emergency purchases; certain municipal hospital purchases, goods purchased from agencies for the blind or severely handicapped; goods purchased from correctional institutions; purchases under state and county contracts; and surplus and secondhand purchases from another governmental entity.
