LOCAL LAW #6-2024

A Local Law Chapter 57, of the Code of the Village of Lake Grove, and to amend Chapter 57, Article I. Places of Assembly and Entertainment

§ 57-5. Restrictions

C. Operation and parking of a food tuck or cart or peddling of any other merchandise are to be restricted in all districts within the Village by any person or entity and shall be unlawful without first obtaining a permit for such purpose from the Village Board through application of a special permit. A special permit for food peddling will only be granted with a valid certificate from the Suffolk County Board of Health, and proof of required insurance. All requests for such permits must be applied for at least thirty days in advance and must be accompanied by a letter from the property owner if the applicant is other than the owner of said property. There shall be a non-refundable application fee of \$100.00 or a permit for three days or less, a \$500.00 fee for up to two weeks, and a fee of \$3,000.00 for more than two weeks, not to exceed one year.


