A local law to amend Lake Success Code Chapter 60 entitled "Health, Safety and Sanitation."

BE IT ENACTED by the Board of Trustees of the Village of Lake Success as follows:

Section One. Lake Success Code Chapter 60 entitled "Health, Safety and Inspection," section 60-4 entitled "Removal of garbage and refuse," subsection (A) is hereby amended to read as follows:

§ 60-4 Removal of garbage and refuse.

A. Every owner of any premises, improved or unimproved, in the village shall keep all garbage thereon in a metal or other watertight container or containers, each with a tight-fitting cover which shall be kept on at all times, such container or containers to be of such size as to be easily handled manually, the container and contents thereof not to exceed 75 pounds in weight. Owner shall store containers in a location that is not visible from the street and garbage contractor shall remove garbage from that location. Alternatively, owner may place the containers at the front corner of the garage for garbage pick up at 7:00 a.m. and then must relocate containers to a location that is not visible from the street.

Section Two. This local law shall take effect immediately upon filing with the Secretary of State.
