AN ORDINANCE AMENDING THE ANIMAL LICENSING REGULATIONS OF THE MUNICIPAL CODE OF THE CITY OF LAKE LOTAWANA

WHEREAS, the City of Lake Lotawana ("City") desires to amend the Municipal Code of the City of Lake Lotawana ("Code"); and

WHEREAS, the City desires to amend the language of the Code for animal licensing to allow for a free animal license that will run with the animal for the lifetime of the animal.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF LAKE LOTAWANA, MISSOURI, that:

Section 1.

The Annual Animal License Fees portion of Section 100.230 Adoption of Schedule shall be repealed.

Section 205.020 Vaccination and Licensing shall be amended as follows:

205.020.B.2

Upon filing of the application the City will issue a numbered metal tag to the owner. The City shall maintain records of all such licenses, arranged numerically by tag numbers, to include the by owners' names, addresses, and contact information. Such records shall be available to the public during regular business hours

205.020.C shall be amended as follows:

- 1. The official license tag shall be attached to a suitable collar or harness which shall be worn by the animal at all times.
- 2. If tag is lost or mutilated, a new tag shall be obtained from the City at no and the new tag number shall be entered in the City's files.

205.020.D shall be repealed.

<u>Section 2.</u> The sections, paragraphs, sentences, clauses, and phrases of this ordinance shall be severable. In the event that any such section, paragraph, sentence, clause or phrase of this ordinance is found by a court of competent jurisdiction to be invalid, the remaining portions of this ordinance are valid, unless the court finds the valid portions of this ordinance are so essential to and inseparably connected with and dependent upon the void portion that it cannot be presumed that the City has enacted the valid portions without the

void ones, or unless the court finds that the valid portions, standing alone, are incomplete and are incapable of being executed in accordance with the legislative intent.

Section 3. This Ordinance shall be governed by and construed in accordance with the applicable laws of the State of Missouri.

Section 4. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 5. This Ordinance shall take effect and be in force from and after its passage.
