ORDINANCE NO. 2023-19

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 194 "VEHICLES AND TRAFFIC" OF THE CODE OF THE BOROUGH OF LEONIA

WHEREAS, the Mayor and Council of the Borough of Leonia has determined that there is a need to amend Chapter 194 "Vehicles and Traffic" of the Code of the Borough of Leonia.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Leonia, as follows:

Section 1.

Chapter 194 "Vehicles and Traffic" Article XIV "Schedules" Section 194-39 "Schedule X: Loading Zones" of the Code of the Borough of Leonia is amended and supplemented, as follows (deletions indicated by "---", additions indicated by **bold**):

§ 194-39. Schedule X: Loading Zones.

In accordance with the provisions of § 194-16, the following described streets or parts of streets are hereby designated as loading zones in the described direction indicated:

Name of Street	Side	Location
Broad Avenue	East	Beginning at the east edge of Fort Lee Road and ending at a point 67 feet southerly along Broad Avenue on Monday through Friday between the hours of 9:00 a.m. and 2:00 p.m.
Broad Avenue	West	Beginning at a point 58 feet northerly of the northerly curb of Hillside Avenue and extending to a point 15 feet northerly thereof
Broad Avenue	West	Beginning at a point 96 feet south of the southerly curbline of Borough Place and extending to a point 34 feet southerly thereof
Broad Avenue	West	Beginning at a point 130 feet north of the northerly curbline of Fort Lee Road and extending to a point 32 feet northerly thereof
Magnolia Place	North	Beginning at a point 51 feet east of the easterly curbline of Broad Avenue and extending to a point 106 feet easterly thereof between the hours of 10:00 a.m. and 1:00 p.m.
Woodland Place	North	Beginning at a point 223 feet from the easterly curbline of Broad Avenue, which is the easterly curbline of the existing right-of-way (driveway) to a point forty feet east therefrom

The remainder of Section 194-39 remains unchanged.

Section 2.

Should any section, part or provision of this ordinance be held unconstitutional or invalid, such decision shall not affect the validity of this ordinance as a whole, or any other part thereof.

Section 3.

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 4.

This ordinance shall take effect immediately upon publication and final passage according to law.
